TO THE

NINTH AMENDED AND RESTATED CERTIFICATE OF INCORPORATION

OF

HAPPIFY INC.

(Pursuant to Section 242 of the Delaware General Corporation Law)

Happify Inc. (the "**Corporation**"), a corporation organized and existing under and by virtue of the General Corporation Law of the State of Delaware.

DOES HEREBY CERTIFY:

FIRST: The name of the Corporation is Happify Inc., and that this Corporation was originally incorporated pursuant to the General Corporation Law of the State of Delaware on October 12, 2011 under the name Spring, Inc.

SECOND: The Ninth Amended and Restated Certificate of Incorporation of the Corporation is hereby amended by striking out Article I thereof in its entirety and by substituting in lieu of said Article the following new Article:

"The name of this Corporation is Twill, Inc. (the "**Corporation**" or this **Corporation**")."

THIRD: This Amendment No 2. to the Ninth Amended and Restated Certificate of Incorporation herein has been duly adopted and written consent has been given in accordance with the provisions of Section 141(f) and 242 of the General Corporation Law of the State of Delaware.

FOURTH: The amendment to the Ninth Amended and Restated Certificate of Incorporation herein certified shall become effective upon the filing of this Amendment No. 2 with the Office of the Secretary of State of the state of Delaware.
