## TRADEMARK RELEASE AND REASSIGNMENT

THIS TRADEMARK RELEASE AND REASSIGNMENT (this “*Release*”) is made as of June 22, 2022, by Twin Brook Capital Partners, LLC, in its capacity as administrative agent for itself and the other Lenders (in such capacity, “*Agent*”). Capitalized terms used but not defined herein shall have the same meanings assigned to such terms in the Trademark Security Agreement (as defined below).

### WITNESSETH:

WHEREAS, RAF Holding Company, a Delaware corporation and Argus Group Holdings, LLC, a Delaware limited liability company (each a “*Grantor*” and, collectively, the “*Grantors*”), were party to that certain Guaranty and Security Agreement, dated as of May 24, 2017 (the “*Security Agreement*”) and the Trademark Security Agreement, dated as of May 24, 2017, in favor of Agent (the “*Trademark Security Agreement*”), pursuant to which the Grantors granted to Agent for the benefit of the Secured Parties a lien on and security interest (the “*Security Interest*”) in the Trademark Collateral, including the Trademarks listed on the attached Schedule A;

WHEREAS, the Trademark Security Agreement was recorded by the United States Patent and Trademark Office on May 24, 2017, at Reel 6068, Frame 0073;

WHEREAS, Grantors have requested that Agent release its Security Interest in the Trademark Collateral and reassign any and all rights in the same to the Grantors; and

WHEREAS, Grantors have satisfied and fulfilled all of its obligations to release Agent’s Security Interest in the Trademark Collateral.

NOW THEREFORE, for good and valuable consideration, receipt and sufficiency of which are hereby acknowledged, Agent hereby (i) fully releases, discharges, terminates and cancels the Security Interest in the Trademark Collateral, (ii) reassigns, grants and conveys to Grantors, without any representation, recourse or undertaking by Agent, any and all of Agent’s right, title and interest in and to the Trademark Collateral and (iii) terminates the Trademark Security Agreement.

The Grantors, and any successor to the Grantors (including any person or entity hereafter holding any right, title or interest in or to the Trademark Collateral) are hereby authorized to record this Release in the United States Patent and Trademark Office.

THIS RELEASE SHALL BE GOVERNED BY, AND CONSTRUED IN ACCORDANCE WITH, THE LAWS OF THE STATE OF NEW YORK.
