RELEASE OF INTELLECTUAL PROPERTY SECURITY AGREEMENT

WHEREAS, by the Intellectual Property Security Agreement dated March 25, 2016 (the "Security Agreement"), originally recorded on April 5, 2016 in the Trademark Assignment database of the United States Patent and Trademark Office ("USPTO") at Reel 5765 Frame 0463, Trialon Corporation (f/k/a Trialon Acquisition Company), a Michigan corporation, Trialon Holding Company, a Delaware corporation, CRL-B, LLC, a Michigan limited liability company, and RTC-K, LLC, a Michigan limited liability company (collectively, "Grantors"), granted to First National Bank of Pennsylvania, a national banking association ("Releasor"), a continuing security interest in all of Grantors' right, title and interest in and to any and all of Grantors': (a) industrial designs, patents, patent registrations, patent applications, trademarks, trademark registrations, trademark applications, service marks, trade names, domain names, and copyrights registrations and other intellectual property rights or registrations, whether federal, state or foreign, including in the trademarks identified in Schedule 1, (b) common law trademark rights, copyrights, rights in trade dress, publicity, works of authorship and other unregistered copyrightable material, improvements, and proprietary and confidential information, including, without limitation, personal, financial, and other sensitive data, plans, know-how, processes, formulae, algorithms trade secrets and inventions; (c) renewals, continuations, extensions, reissues and divisions of any of the foregoing; (d) rights to sue for past, present and future infringements or any other commercial tort claims relating to any of the foregoing; (e) general intangibles and all intangible intellectual or similar property of any Grantor connected with and symbolized by any of the foregoing; (f) goodwill associated with any of the foregoing; and (g) Proceeds of any of the foregoing (as "Proceeds is defined in the Uniform Commercial Code) (collectively, clauses (a)-(g), the "Collateral); and



NOW, THEREFORE, for good and valuable consideration, Releasor does hereby release and discharge (in each case without recourse and without representation or warranty of any kind or nature, express or implied) the security interest, liens, and all other rights, if any, it may have in the Collateral granted to it by Grantors pursuant to the Security Agreement of the same date and which were recorded in the USPTO.
