NOTICE OF GRANT OF SECURITY INTEREST

FOR GOOD AND VALUABLE CONSIDERATION, receipt and sufficiency of which are hereby acknowledged, GETFIVE LLC, a Delaware limited liability company (f/k/a TFOCC, LLC, a Delaware limited liability company; the “Grantor”), hereby grants to WEBSTER BANK, NATIONAL ASSOCIATION, as Administrative Agent, for the benefit of the Secured Parties (the “Grantee”), a continuing security interest in (i) all of the Grantor’s right, title and interest in, to and under to the United States trademarks, trademark registrations and trademark applications (the “Marks”) set forth on Schedule A attached hereto, (ii) all proceeds and products of the Marks, (iii) the goodwill of the businesses with which the Marks are associated, and (iv) all causes of action arising prior to or after the date hereof for infringement of any of the Marks or unfair competition regarding the same; provided, that, for the avoidance of doubt such grant shall not include any “intent to use” trademark application for which a statement of use or amendment to allege use has not been filed and accepted with the United States Patent and Trademark Office.

THIS GRANT is made to secure the prompt payment and performance of all the Obligations of the Grantor, as such term is defined in the Loan and Security Agreement entered into by, among others, the Grantor and the Grantee, dated as of December 10, 2020 (as amended, modified, restated and/or supplemented from time to time, the “Loan Agreement”). The rights and remedies of the Grantee, with respect to the security interest granted herein are as set forth in the Loan Agreement, all terms and provisions of which are incorporated herein by reference. In the event that any provision of this Grant is deemed to conflict with the Loan Agreement, the provisions of the Loan Agreement shall govern.


