TERMINATION OF TRADEMARK SECURITY AGREEMENT

This TERMINATION OF TRADEMARK SECURITY AGREEMENT (this “*Termination*”), dated as of April 22, 2022, is made by WEBSTER EQUITY PARTNERS, LLC (f/k/a WEBSTER CAPITAL MANAGEMENT, L.L.C.), the Agent for the Purchasers (the “*Agent*”), in favor of each of Dover Saddlery, Inc., a Massachusetts corporation (“*Dover MA*”), and Dover Saddlery, Inc., a Delaware corporation (as successor in interest to each of Horsepharm.com, LLC, a Delaware limited liability company, and Smith Brothers, Inc., a Texas corporation) (“*Dover DE*”, and together with Dover MA, individually, a “*Grantor*”, and collectively, the “*Grantors*”).

WHEREAS, pursuant to that certain Amended and Restated Note Purchase Agreement, dated as of October 18, 2017 (as amended, restated, amended and restated, supplemented or otherwise modified and in effect from time to time, the “*Note Purchase Agreement*”), by and among (i) Dover Saddlery, Inc., a Delaware corporation, as an Issuer, (ii) the other Issuers party thereto from time to time, (iii) the other Persons party thereto that are designated as Note Parties, (iv) the Agent, and (v) the Purchasers party thereto from time to time, the Grantors granted to the Agent (for its own benefit and for the benefit of the other Secured Parties) a security interest in and to the Trademark Collateral (as defined in the Trademark Security Agreement (as defined below));

WHEREAS, in connection with the Note Purchase Agreement, the Grantors and GarMark SBIC Advisors LLC (“*GarMark*”) executed and delivered that certain Trademark Security Agreement, dated as of July 1, 2015 (the “*Trademark Security Agreement*”), which was recorded with the United States Patent and Trademark Office (trademark division) (the “*USPTO*”) on July 8, 2015 at Reel/Frame 5594/0163. On or about October 18, 2017, GarMark and the Agent executed and delivered that certain Assignment of Trademark Security Agreement (the “*Assignment of Trademark Security Agreement*”), pursuant to which GarMark assigned all of its rights, title and interest in and to the Trademark Security Agreement and the Trademark Collateral described therein to the Agent, which was recorded with the USPTO on October 23, 2017 at Reel/Frame 6187/0442;

WHEREAS, the Grantors have requested that the Agent terminate, release and discharge fully its and the other Secured Parties’ security interests in the Trademark Collateral granted pursuant to the Note Purchase Agreement, the Trademark Security Agreement, and the Assignment of Trademark Security Agreement; and

WHEREAS, the Grantors have requested that the Agent provide a document for recording with the USPTO to evidence the release of the Agent’s and other Secured Parties’ security interests in and liens on the Trademark Collateral granted pursuant to the Note Purchase Agreement, the Trademark Security Agreement, and the Assignment of Trademark Security Agreement.

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the Agent hereby agrees as follows:

1. Defined Terms. All capitalized terms used herein, but not otherwise defined herein, shall have the respective meanings ascribed in or otherwise referenced in the Note Purchase Agreement, the Trademark Security Agreement, and the Assignment of Trademark Security Agreement, as applicable.
2. Termination. The Agent, without representation or warranty of any kind, hereby terminates and cancels the Trademark Security Agreement, the Assignment of Trademark Security Agreement, and all such security interests in and liens on the Trademark Collateral granted pursuant to the Note Purchase Agreement, the Trademark Security Agreement, and the


Assignment of Trademark Security Agreement, including the trademarks and trademark licenses identified in Exhibit A hereto.

3. Recording. The Agent authorizes and requests that this Termination be recorded with the USPTO at the sole cost and expense of the Grantors.
