TRADEMARK ASSIGNMENT

THIS TRADEMARK ASSIGNMENT ("Assignment"), effective as of 5/23/22 (the "Effective Date"), is made by and between LP-KP IP Holdings, LLC ("Assignor"), a limited liability company organized and existing under the laws of California, with a principal place of business at 2300 S. Sepulveda Blvd., Los Angeles, CA 90064, and FLRish IP, LLC ("Assignee"), a limited liability company organized and existing under the laws of California with a principal place of business 2100 Embarcadero Street, Suite 205, Oakland, CA 94606 (individually referred to as a "Party" and collectively as the "Parties").

RECITALS

WHEREAS, Assignor warrants it owns all right, title, and interest, in the marks as identified in Exhibit A (the "Marks");

WHEREAS, Assignee is the successor of Assignor's business to which the mark pertains;

WHEREAS, Assignee desires to own all statutory and common law rights, title, and interest in the Marks;

NOW THEREFORE, in consideration of the mutual covenants and promises herein, as well as other good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged, the Parties agree as follows:

- 1. Assignor hereby conveys, transfers, and assigns to the Assignee, nunc pro tunc, all rights, title, and interest in the Marks, together with:
a. The goodwill of the business relating to the services on which the Marks are used and for which it is registered for;
b. All income, royalties, and damages hereafter due or payable to Assignor with respect to the Marks, including without limitation, damages, and payments for past or future infringements and misappropriations of the Marks; and
c. All rights to sue and collect damages for past, present, and future infringement or misappropriation of the Marks.
2. These assigned rights shall be held and enjoyed by Assignee for Assignee's own use and enjoyment, and for the use and enjoyment of its successors, assigns and other legal representatives, at common law and/or to the end of the term or terms of which registration pertaining to the Marks may be granted, or renewed, as fully and entirely as the same would have been held and enjoyed by Assignor if this Agreement had not been made.
3. Assignor agrees to cooperate with Assignee to execute such additional documents as are necessary to defend, register, or otherwise give full effect to and perfect the rights of Assignee in the Marks and take such further actions as Assignee may reasonably request in order to register and record this Assignment at the appropriate registries to demonstrate Assignee's title in the Marks.

IN WITNESS WHEREOF, the undersigned represents that it has authority to execute this Agreement and to carry out all obligations imposed hereunder, has read, understands, and agreed to the terms of this Assignment, and has executed this instrument as of the date set forth below.
