WHEREAS, the parties entered into a Purchase Agreement, wherein Assignor, sold, assigned and transferred certain intellectual property to Assignee;


WHEREAS, Assignee wishes to record the assignment of intellectual property to Assignee with the United States Patent and Trademark Office;


