RELEASE OF SECURITY INTEREST IN TRADEMARKS (“Release”), effective as of June 15, 2022, made by COÖPERATIEVE RABOBANK U.A., NEW YORK BRANCH, in its capacity as administrative agent for the Secured Parties (in such capacity, the “Administrative Agent”), with its principal offices at 245 Park Avenue, New York, New York 10167, in favor of BRUEGGER’S ENTERPRISES, INC., a Delaware corporation (“BE”), CARIBOU COFFEE COMPANY, INC., a Minnesota corporation (“CCC”), EINSTEIN AND NOAH CORP., a Delaware corporation (“ENC”), ARABICA FUNDING, INC., a Delaware corporation (“AF”), CHESAPEAKE BAGEL FRANCHISE CORP., a New Jersey corporation (“CBFC”), NOAH’S NEW YORK BAGELS COMPANY, a Minnesota corporation (“NNYBC”), MANHATTAN BAGEL COMPANY, INC., a New Jersey corporation (“MBC”), EINSTEIN NOAH RESTAURANT GROUP, INC., a Delaware corporation (“ENRG”), and EINSTEIN/NOAH BAGEL PARTNERS, INC., a California corporation (“ENBP”, and together with BE, CCC, ENC, AF, CBFC, NNYBC, MBC and ENRG, each, a “Grantor”, and collectively, the “Grantors”). Capitalized terms used herein (including in the preamble and recitals hereto) but not otherwise defined herein have the meanings given to them in the Security Agreement (as defined in the First Security Agreement) or, if not defined therein, in the Credit Agreement (as defined in the First Security Agreement).

WHEREAS, pursuant to that certain Trademark Security Agreement dated as of February 6, 2015 (the “First Security Agreement”), made by CCC, AF, ENRG, ENBP, ENC, MBC and CBFC in favor of Administrative Agent, each such Grantor granted, collaterally assigned, and pledged to Administrative Agent, for the ratable benefit of the Secured Parties, a security interest in the Trademark Collateral (as defined in the First Security Agreement, the “First Security Agreement Trademark Collateral”), including without limitation those items listed on Schedule 1 hereto;

WHEREAS, the First Security Agreement was recorded in the Trademark Division of the United States Patent & Trademark Office on February 9, 2015, at Reel 005455, Frame 0759;

WHEREAS, pursuant to that certain Trademark Security Agreement dated as of May 11, 2016 (the “Second Security Agreement”), made by NNYBC in favor of Administrative Agent, such Grantor granted, collaterally assigned, and pledged to Administrative Agent, for the ratable benefit of the Secured Parties, a security interest in the Trademark Collateral (as defined in the Second Security Agreement, the “Second Security Agreement Trademark Collateral”), including without limitation those items listed on Schedule 2 hereto;

WHEREAS, the Second Security Agreement was recorded in the Trademark Division of the United States Patent & Trademark Office on May 11, 2016, at Reel 005790, Frame 0518;

WHEREAS, pursuant to that certain Trademark Security Agreement dated as of October 5, 2017 (the “Third Security Agreement”), made by BE, CCC, ENC, AF, CBFC, NNYBC and MBC in favor of Administrative Agent, each such Grantor granted, collaterally assigned, and pledged to Administrative Agent, for the ratable benefit of the Secured Parties, a security interest in the Trademark Collateral (as defined in the Third Security Agreement, the “Third Security Agreement Trademark Collateral”), including without limitation those items listed on Schedule 3 hereto;

WHEREAS, the Third Security Agreement was recorded in the Trademark Division of the United States Patent & Trademark Office on October 5, 2017, at Reel 006175, Frame 0535;

WHEREAS, pursuant to that certain Trademark Security Agreement dated as of November 17, 2017 (the “Fourth Security Agreement”), made by AF and ENC in favor of Administrative Agent, each

such Grantor granted, collaterally assigned, and pledged to Administrative Agent, for the ratable benefit of the Secured Parties, a security interest in the Trademark Collateral (as defined in the Fourth Security Agreement, the “Fourth Security Agreement Trademark Collateral”, and together with the First Security Agreement Trademark Collateral, the Second Security Agreement Trademark Collateral and the Third Security Agreement Trademark Collateral, the “Trademark Collateral”), including without limitation those items listed on Schedule 4 hereto;

WHEREAS, the Fourth Security Agreement was recorded in the Trademark Division of the United States Patent & Trademark Office on November 17, 2017, at Reel 006207, Frame 0973; and

WHEREAS, Administrative Agent now desires to release the entirety of its security interest in the Trademark Collateral.


