**TERMINATION AND RELEASE OF
FIRST LIEN TRADEMARK SECURITY AGREEMENT**

This Termination and Release of First Lien Trademark Security Agreement (“Release”) is made as of July 13, 2022, by **MACQUARIE CAPITAL FUNDING LLC**, a Delaware limited liability company (the “Administrative Agent”) in favor of **VISTAGE WORLDWIDE, INC.**, a Delaware corporation with an address at 11452 El Camino Real, Suite 400, San Diego, California 92130 (the “Grantor”).

WITNESSETH:

WHEREAS, the Grantor entered into a First Lien Trademark Security Agreement (the “Trademark Security Agreement”) dated March 3, 2020 with the Administrative Agent, notice of which was recorded on March 3, 2020 at the United States Patent and Trademark Office at Reel 6881, Frame 0502.

Capitalized terms used but not otherwise defined herein have the meanings given to them in the Trademark Security Agreement.

WHEREAS, Grantor granted the Administrative Agent, under the terms of the Trademark Security Agreement, a continuing security interest (the “Security Interest”) in favor of the Administrative Agent, in and to all of its right, title and interest in, to and under all Trademarks of the Grantor (other than Excluded Assets), including those Trademarks listed in **Schedule A** (the “Released Collateral”).


WHEREAS, the Administrative Agent has agreed to terminate and release its security interest in all such Released Collateral as herein provided.

NOW, THEREFORE, in consideration of the foregoing and intending to be legally bound, the Administrative Agent hereby terminates and cancels the Trademark Security Agreement and releases, terminates and discharges any and all of its interest in the Released Collateral of the Grantor, and assigns, transfers and conveys to Grantor the Security Interest.
