**DECLARATION OF HOWARD GANZ IN SUPPORT OF  
REQUEST TO CORRECT IMPROPER ASSIGNMENT**

1. I, Howard Ganz, am the Manager and CEO at MIDWEST-CBK, LLC and President at GANZ. I am duly authorized by MIDWEST-CBK, LLC and GANZ to make this Declaration and have been advised and verily believe the facts stated herein:

2. This Declaration is submitted in support of the Request to Correct Improper Assignment for the above-captioned registrations.

3. I respectfully request correction of the improper assignment of Registration Nos. 4248872 and 4248875 from GP GLOBAL LIMITED to MVP GROUP INTERNATIONAL, INC., recorded on January 31, 2019 at Reel/Frame 6545/0590 by Tamara Pester, Esq. of Tamara S. Pester, LLC.

4. Ms. Pester acknowledged the improper assignment of these two registrations but indicated that her client is unlikely to approve the expenses associated with correcting the error, which is why MIDWEST-CBK, LLC is seeking to correct the error itself.

5. For Registration No. 4248872, the proper transfers in ownership should reflect the following chain of title: 1) from GP GLOBAL LIMITED to MVP GROUP INTERNATIONAL, INC.; 2) from MVP GROUP INTERNATIONAL, INC. to MIDWEST-CBK, LLC; and 3) from MIDWEST-CBK, LLC to GANZ.

6. For Registration No. 4248875, the proper transfers in ownership should reflect the following chain of title: 1) from GP GLOBAL LIMITED to MVP GROUP INTERNATIONAL, INC.; and 2) from MVP GROUP INTERNATIONAL, INC. to MIDWEST-CBK, LLC.


5. However, after the assignment from MVP GROUP INTERNATIONAL, INC. to MIDWEST-CBK, LLC, the above-noted improper assignment from GP GLOBAL LIMITED to MVP GROUP INTERNATIONAL, INC. was recorded.

7. Due to the erroneous inclusion of Registration Nos. 4248872 and 4248875 in the assignment from GP GLOBAL LIMITED to MVP GROUP INTERNATIONAL, INC., and that these registrations were rightfully owned by MIDWEST-CBK, LLC at the time of said assignment, the assignment is null and void and does not affect MIDWEST-CBK, LLC's ownership of the MIDWEST-CBK trademark rights in the United States.

8. As to Registration No. 4248872 only, a subsequent assignment from MIDWEST-CBK, LLC to GANZ was recorded on July 24, 2020 at Reel/Frame 7007/0225, which resulted in the registrant/owner name for this registration being updated at the Trademark Office to GANZ. This assignment is correct and MIDWEST-CBK, LLC intends to record the same assignment against Registration No. 4248875.

The signatory being warned that willful false statements and the like are punishable by fine or imprisonment, or both, under 18 U.S.C. 1001, and that such willful false statements and the like may jeopardize the validity of the application or submission or any registration resulting therefrom, declares that all statements made of his own knowledge are true and all statements made on information and belief are believed to be true.
