WHEREAS, ASSIGNOR is willing to assign to ASSIGNEE all rights, title, and interest as ASSIGNOR may possess in and to the Trademark and Registration in the U.S.;

NOW, THEREFORE, for good and adequate consideration, the receipt and sufficiency of which is hereby acknowledged, ASSIGNOR hereby assigns, transfers, and conveys to ASSIGNEE all rights, title, and interest as ASSIGNOR may possess in and to the following:


- (1) the Trademark set forth in Schedule A; and
