This Certificate of Merger is being executed and filed pursuant to Section 251(c) of the General Corporation Law of the State of Delaware (the “DGCL”) by Citizens Financial Group, Inc. Citizens Financial Group, Inc. hereby certifies that:

1. The name and state of incorporation of each of the constituent corporations are as follows:

- (a) Investors Bancorp, Inc., a Delaware corporation (the “Company”); and
- (b) Citizens Financial Group, Inc., a Delaware corporation (“Parent”).

2. An Agreement and Plan of Merger (the “Merger Agreement”), dated as of July 28, 2021, by and between Parent and the Company, setting forth the terms and conditions of the merger of the Company with and into Parent (the “Merger”) with Parent surviving the Merger, has been approved, adopted, certified, executed and acknowledged by each of the constituent corporations in accordance with Section 251(c) of the DGCL.

3. Parent shall be the surviving corporation in the Merger (the “Surviving Corporation”). At the effective time of the Merger herein certified, the name of the Surviving Corporation shall be Citizens Financial Group, Inc.

4. At the effective time of the Merger herein certified, the certificate of incorporation of the Surviving Corporation shall be the certificate of incorporation of Parent as in effect immediately prior to the Merger.


5. The executed Merger Agreement is on file at the offices of the Surviving Corporation at the following address: One Citizens Plaza, Providence, Rhode Island 02903.
