**STATE OF MARYLAND  
ARTICLES OF CONVERSION  
FROM A MARYLAND CORPORATION  
TO A MARYLAND LIMITED LIABILITY COMPANY**

These Articles of Conversion (the "Articles"), dated as of June 27, 2022, have been duly executed and filed by the undersigned, to convert Webb-Mason, Inc., a Maryland corporation (the "Corporation"), to Webb-Mason, LLC, a Maryland limited liability company (the "LLC"), pursuant to Section 3-903 of the Maryland General Corporation Law.

**FIRST:** The name of the Corporation immediately prior to filing these Articles is "Webb-Mason, Inc." and the date of filing of the original Articles of Incorporation with the Maryland State Department of Assessments and Taxation ("SDAT") was July 19, 1989.

**SECOND:** The Corporation will be converted into a Maryland limited liability company to be known as "Webb-Mason, LLC" (such conversion, the "Conversion").

**THIRD:** The Conversion has been approved by the written consent of the sole stockholder of the Corporation in accordance with Section 3-900 *et seq.* of the Corporations & Associations Article of the Maryland Code and Section 4A-1103 of the Corporations & Associations Article of the Maryland Code.

**FOURTH:** As a result of the Conversion, each outstanding share of the Corporation's capital stock will be converted directly into one unit of membership interest of the LLC.

**FIFTH:** These Articles of Conversion shall be effective upon their filing with SDAT.


