RELEASE OF TRADEMARK SECURITY AGREEMENT

This **RELEASE OF TRADEMARK SECURITY AGREEMENT** (the “*Release Agreement*”), is dated as of July 13, 2022, by BANK OF AMERICA, N.A., a national banking association, as agent (in such capacity, the “*Agent*”) for the Lenders and other Secured Parties.

WHEREAS, NUSFC, LLC, a Delaware limited liability company (the “*Grantor*”), executed and delivered that certain Trademark Security Agreement, dated as of October 25, 2021 (as amended, restated, supplemented or otherwise modified prior to the date hereof, the “*Security Agreement*”), granting the Agent a security interest in and lien on certain trademarks and trademark applications (collectively, “*Collateral*”) described therein, which includes the Collateral listed on Schedule A hereto, which was recorded with the United States Patent and Trademark Office (“*Office*”) on October 26, 2021, at Reel 007472, Frame 0045;

WHEREAS, the Grantor has requested that the Agent release, discharge and terminate all liens and security interests granted to the Agent under the Security Agreement.

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the Agent hereby (a) releases the Grantor from the Security Agreement, (b) releases, terminates and discharges all liens and security interests and all right, title and interest in, to and under the Collateral, and reassigns to Grantor any rights it may have in the Collateral, and (c) authorizes Grantor to record this Release Agreement at the Office.
