RELEASE OF SECURITY INTEREST IN TRADEMARKS

THIS RELEASE OF SECURITY INTEREST IN TRADEMARKS (the “Release”) is made as of July 1, 2022, by ALLY BANK, as agent (in such capacity, together with its successors and permitted assigns in such capacity, “Agent”) for the Lenders (as defined in the Security Agreement defined below). Capitalized terms used but not defined herein shall have the same meanings assigned to such terms in the Security Agreement (as defined below).

W I T N E S S E T H:

WHEREAS, MNG Health LLC (“Grantor”) and Agent are parties to that certain Trademark Security Agreement dated as of December 16, 2019 (as amended, restated, supplemented or otherwise modified, the “Security Agreement”) pursuant to which Grantor granted to Agent a lien on and security interest in, to and under the Trademark Collateral as security for certain obligations owing by Grantor to Agent;

WHEREAS, the Security Agreement was recorded by the Trademark Division of the United States Patent and Trademark Office on December 16, 2019, at Reel 6816, Frame 0853; and

WHEREAS, Grantor has requested that Agent release its lien on and security interest in, to and under the Trademarks and all Trademark Collateral and reassign any and all rights in the same to Grantor.

NOW THEREFORE, for good and valuable consideration, receipt and sufficiency of which are hereby acknowledged:

1. Agent hereby releases its lien on and security interest in, to and under all of Grantor’s respective right, title and interest in, to and under the Trademark Collateral, which includes but is not limited to the following:

- (a) all of its Trademarks, including those referred to on Schedule 1 hereto;
- (b) all of the goodwill of the business connected with the use of, and symbolized by, each such Trademark;
- (c) all renewals and extensions of the foregoing; and
- (d) all income, royalties, proceeds and liabilities at any time due or payable or asserted under and with respect to any of the foregoing, including, without limitation, all rights to sue and recover at law or in equity for any past, present and future infringement, misappropriation, dilution, violation or other impairment thereof.

2. Agent hereby reassigns, grants and conveys to Grantor, without any representation, recourse or undertaking by Agent, any and all of Agent’s right, title and interest in, to and under the Trademark Collateral. Agent hereby authorizes Grantor (or their designee) to file this Release with the United States Patent and Trademark Office.
