## CONFIRMATORY TRADEMARK ASSIGNMENT

Assignor does hereby confirm that it has sold, conveyed, assigned, and transferred to Assignee all of Assignor's right, title and interest in and to (i) the Trademarks, together with the goodwill symbolized thereby, and (ii) all benefits, privileges, causes of action, common law rights, and remedies relating thereto throughout the world, including, without limitation, all of Assignor's rights to (a) apply for and maintain all registrations, renewals and/or extensions thereof, (b) bring actions and recover damages for past, present and future infringement or other violation thereof, and (c) grant licenses or other interests therein.
2. Successors and Assigns. This Agreement and all of its provisions shall be binding upon and inure to the benefit of the parties hereto and their respective permitted successors and assigns.
3. Governing Law; Jurisdiction. This Agreement shall be governed in all respects by the laws of Ireland, without giving effect to the principles of conflicts of law thereof.
4. Counterparts. This Agreement may be executed in one or more counterparts, each of which shall be deemed an original, but both of which together shall constitute one and the same instrument.



