**TERMINATION AND RELEASE OF SECURITY INTEREST IN TRADEMARKS**

THIS TERMINATION AND RELEASE OF SECURITY INTEREST IN TRADEMARKS, dated as of July 15, 2022 (this "Release") is made by Golub Capital Markets LLC, a Delaware limited liability company, as administrative agent and collateral agent (in such capacity, together with its successors and assigns, the "Agent"), in favor of El Car Wash, LLC, a Delaware limited liability company (the "Grantor"),

**RECITALS**

**WHEREAS**, Agent and the Grantor were parties to that certain Security Agreement ("Security Agreement") and that certain Trademark Security Agreement, both dated as of February 1, 2022 (the "Trademark Security Agreement"), pursuant to which the Grantor granted, collaterally assigned and pledged to Agent, for the benefit of the Secured Parties, a continuing security interest in all of the Grantor's right, title and interest in, to and under Trademark Collateral (as defined in the Trademark Security Agreement), including the Trademarks set forth on Schedule 1 hereto; and

**WHEREAS**, the Trademark Security Agreement was recorded by the United States Patent and Trademark Office ("USPTO") on May 18, 2022, at Reel 7725, Frame 0294; and

**WHEREAS**, Agent has agreed to release its security interest in and lien on all of the Grantor's right, title and interest in, to and under the Trademark Collateral and reassign the same to the Grantor.

**NOW, THEREFORE**, in consideration of the premises and for other good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged:

1. Agent hereby releases, terminates and discharges its continuing security interest in the Trademark Collateral.

2. Agent hereby reassigns, grants and conveys to the Grantor, without any representation, recourse or undertaking by Agent, all of Agent's right, title and interest (if any) in and to the Trademark Collateral.

Agent agrees to take all further actions, and provide to the Grantor and its respective successors, assigns or other legal representatives, all such cooperation and assistance (including, without limitation, the execution and delivery of any and all documents or other instruments), reasonably requested by the Grantor, at the Grantor's sole cost and expense, to more fully and effectively effectuate the purposes of this release; provided that any such further action shall be without representation or warranty by, or recourse to, the Agent or any Lender. The Agent hereby authorizes and requests that the United States Patent and Trademark Office note and record the present Termination and Release of Security Interest in Trademark Security Agreement.


This Release shall be governed by and construed in accordance with the laws of the State of New York.


