AMENDED AND RESTATED
INTELLECTUAL PROPERTY SECURITY AGREEMENT

This Amended and Restated Intellectual Property Security Agreement, dated as of June 9, 2022 (the "Agreement"), between WESTERN ALLIANCE BANK, an Arizona corporation ("WAB"), as Agent, and PARACHUTE HOME INC., a Delaware corporation ("Grantor"), is made with reference to the Amended and Restated Loan and Security Agreement, dated as of June 9, 2022 (as amended from time to time, the "Loan Agreement"), among Grantor, the Lenders party thereto, and Agent. Terms defined in the Loan Agreement have the same meaning when used in this Agreement.

For good and valuable consideration, receipt of which is hereby acknowledged, Grantor hereby covenants and agrees as follows:

To secure the Obligations under the Loan Agreement, each Grantor grants to Agent, for itself and for the benefit of the Lenders, a security interest in all right, title, and interest of Grantor in any of the following, whether now existing or hereafter acquired or created in any and all of the following property (collectively, the "Intellectual Property Collateral"):

- (a) Copyrights including the Copyrights described in Exhibit A;
- (b) Trademarks including the Trademarks described in Exhibit B;
- (c) Patents including the Patents described in Exhibit C;
- (d) all trade secrets, all design rights, claims for damages by way of past, present and future infringement of any of the rights included above;
- (e) all amendments, renewals and extensions of any of the Copyrights, Trademarks or Patents; and
- (f) all proceeds and products of the foregoing, including without limitation all payments under insurance or any indemnity or warranty payable in respect of any of the foregoing.

The rights and remedies of Agent with respect to the security interests granted hereunder are in addition to those set forth in the Loan Agreement, and those which are now or hereafter available to Agent as a matter of law or equity. Each right, power and remedy of Agent provided for herein or in the Loan Agreement, or now or hereafter existing at law or in equity shall be cumulative and concurrent and shall be in addition to every right, power or remedy provided for herein, and the exercise by Agent of any one or more of such rights, powers or remedies does not preclude the simultaneous or later exercise by Agent of any other rights, powers or remedies.

This Agreement is a Loan Document. This Agreement shall be governed by, and construed in accordance with, the internal laws of the State of California, without regard to principles of conflicts of law.

This Agreement does completely amend and restate the terms and conditions of that certain Intellectual Property Security Agreement dated as of June 19, 2019, between Grantor and WAB (as amended from time to time before the date of this Agreement, the "Original IP Security Agreement"). The security interest described in this Agreement is a continuation of the security interest granted and pledged to WAB under the Original Loan Agreement and the Original IP Security Agreement. Nothing in this Agreement constitutes or shall be deemed to release or otherwise adversely affect any such lien or security interest.
