## INTELLECTUAL PROPERTY ASSIGNMENT

1. **Assignment**. Assignor hereby irrevocably sells, assigns, transfers, and conveys to Assignee, its successors and assigns, and Assignee hereby accepts from Assignor, all of the rights, title, and interests of Assignor in and to the Intellectual Property, together with the goodwill of the business symbolized by the Intellectual Property, with the right to recover for damages and profits and all other remedies for past infringements thereof.

2. **Further Assurances**. Assignor agrees to, at Assignee's expense, perform any further acts and to execute and provide to Assignee all other documents that may be necessary to effect and complete the assignment of the Intellectual Property to Assignee after Assignee's request therefor and to assist Assignee in any manner reasonably requested by Assignee in connection with the assignment, prosecution, enforcement and maintenance of the Intellectual Property.

3. **General Provisions**. This Intellectual Property Assignment may be executed in two or more counterparts, each of which shall be deemed an original. This Intellectual Property Assignment and any counterpart so executed shall be deemed to be one and the same instrument.
