Trademark Assignment

This Trademark Assignment (the "Assignment") is entered into as of August 10, 2022
by and between Monti & Associates, Inc., a Florida corporation ("Monti"), in favor of
STVT-AAI EDUCATION INC. a corporation of the
state of Texas ("Assignee"), with reference to the following facts and
circumstances:

WHEREAS, Monti has used and owns certain common law trademark rights in and to
the trademark and trade name ANCORA in connection with educational services, and owns
U.S. Reg. No. 4504635 for ANCORA for educational services, namely, continuous learning
programs for business executives in the fields of professional and personal development, and
developing educational materials, namely, manuals for others, namely, business executives in
the field of professional and personal development (the "Trademark Registration") (all of the
foregoing may be referred to collectively as the "Trademark");

WHEREAS, for good and valuable consideration, the receipt and adequacy of which are
hereby acknowledged, Monti desires to assign to Assignee all of Monti's right, title and interest
in and to the Trademark.

NOW, THEREFORE, Monti and Assignee hereby agree as follows:

Assignment of Trademark. Monti hereby sells, conveys, transfers and delivers to
Assignee all of Monti's right, title and interest in, to and under the Trademark, and all
registrations issuing therefrom, together with the goodwill associated therewith, and the right to
sue for, and recover for, any past and future infringements thereof, to be held and enjoyed by
Assignee, its successors and assigns, as fully and entirely as the same would have been held
and enjoyed by Monti had no sale and assignment of said Trademark been made. Monti further
agrees to execute such further documents reasonably required by Assignee to secure and
enforce the rights to the Trademark granted to Assignee under this Agreement. Monti agrees to
provide all assistance reasonably requested by Assignee in the establishment, recordation and
enforcement of Assignee's rights in and to the Trademark, at Assignee's expense.
