### Owner Clarification

The current owner of record for the U.S. trademark registrations listed on the attached schedule (the "Trademarks") is The Trustee of The First Alert Trust, a Minnesota trust, composed of US Bank National Association, a Delaware corporation. However, this characterization of the owner entity information was and is not correct. As discussed below and in the attached declaration in support of this Owner Clarification, the owner previously identified as *The Trustee of The First Alert Trust, a Minnesota trust, composed of US Bank National Association, a Delaware corporation* should instead accurately be characterized as **U.S. Bank National Association, a national banking association organized under the laws of the United States, as Trustee of the First Alert Trust.**

The First Alert Trust is not currently and was never organized and existing under the laws of any state, including Minnesota. Trusts are by definition not created under state law. Rather, trusts are created pursuant to a trust instrument or contract. Therefore, it is not correct to identify a state under whose laws The First Alert Trust exists. The clarified record owner as listed above removes the reference to the trust being a Minnesota trust. Because The First Alert Trust, a Minnesota trust, never existed, this is a correctable error. TMEP Sec. 1201.02(c) ("If the party applying to register the mark is, in fact, the owner of the mark, but there is a mistake in the manner in which the name of the applicant is set out in the application, the mistake may be corrected by amendment.").

Furthermore, U.S. Bank National Association, Trustee of the First Alert Trust, is not currently and was never a corporation organized and existing under the laws of any state, including Delaware. Rather, U.S. Bank National Association has always been a national banking

association organized under the laws of the United States. Therefore, it was and is not correct to identify U.S. National Bank Association as a Delaware corporation. The clarified record owner as listed above identifies U.S. Bank National Association as being a national banking association organized under the laws of the United States. Because an entity called U.S. Bank National Association, a Delaware corporation, never existed, this is a correctable error. TMEP Sec. 1201.02(c).

For the above reasons, the owner requests that the U.S. Patent and Trademark Office accept this clarification for the record to reflect that the owner previously identified as *The Trustee of The First Alert Trust, a Minnesota trust, composed of US Bank National Association, a Delaware corporation* should instead accurately be characterized as **U.S. Bank National Association, a national banking association organized under the laws of the United States, as Trustee of the First Alert Trust.**
