

**WHEREAS**, pursuant the Beneficial Owners have directed the Trustee to transfer ownership of the Trademarks to Ademco Inc., a Delaware corporation, located at 2 Corporate Center Dr., Melville, New York 11747 (the “**Assignee**”) and the Assignee is desirous of acquiring ownership of the Trademarks.


**NOW, THEREFORE**, for good and valuable consideration, receipt of which is hereby acknowledged, the Trustee hereby conveys, transfers and assigns to the Assignee all of the right, title and interest of the Trustee in and to the Trademarks, together with the goodwill of the business symbolized by the Trademarks and the identified registrations therefor, and with all claims arising out of or relating to the use or ownership of the Trademarks.
