TRADEMARK ASSIGNMENT AGREEMENT

This TRADEMARK ASSIGNMENT AGREEMENT (“**Agreement**”) is made effective as of August 3, 2021, by and between Casparian Holdings, LLC, an Oregon limited liability company (“**Assignor**”), and Casparian Production, LLC, an Oregon limited liability company (“**Assignee**”).

WHEREAS, Assignor is the owner of the entire right, title, and interest in and to the trademarks listed on Exhibit A attached hereto (the “**Marks**”).

WHEREAS, Assignor wishes to assign all right, title and interest in and to the Marks, including the goodwill of the business associated therewith to Assignee, its affiliated company, and Assignee is desirous of acquiring the Marks with the goodwill of the business symbolized thereby.

NOW, THEREFORE, for good and valuable consideration the receipt and sufficiency of which is hereby acknowledged, the parties agree as follows:

1. For good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, Assignor hereby irrevocably conveys, transfers, and assigns to Assignee, and Assignee hereby accepts, all of Assignor’s right, title, and interest in and to the Marks, together with the goodwill of the business associated therewith; all rights of any kind of Assignor accruing under any and all of the foregoing; any and all royalties, fees, income, payments, and proceeds now or hereafter due or payable with respect to any and all of the foregoing; and all claims and causes of action with respect to any of the foregoing, whether accruing before, on, or after the date hereof.

2. Assignor does hereby authorize the Commissioner for Trademarks in the United States Patent & Trademark Office, and the empowered official of any country or countries foreign to the United States whose duty it is to record trademark registrations, applications and title thereto, as applicable, to record the Marks and title thereto as the property of Assignee.

3. This Agreement shall be binding upon and inure to the benefit of the parties, and their respective successors and assigns.
