## ASSIGNMENT FOR SECURITY

### TRADEMARKS

WHEREAS, AMERICAN SOCCER COMPANY, INCORPORATED, a California corporation (the "Assignor") has adopted, used and is using, and holds all right, title and interest in and to, the trademarks and service marks listed on the annexed Schedule 1A, which trademarks and service marks are registered or applied for in the United States Patent and Trademark Office (the "Trademarks");

WHEREAS, the Assignor, has entered into a Security Agreement, dated July 20, 2022 (the "Security Agreement"; all capitalized terms not defined herein shall have the respective meaning given to them in the Security Agreement), in favor of Kayne Senior Credit IV Loanco, LLC, in its capacity as Administrative Agent for the benefit of the Secured Parties (the "Assignee");

WHEREAS, pursuant to the Security Agreement, the Assignor granted to the Assignee for the benefit of the Secured Parties a continuing security interest in all right, title and interest of the Assignor in, to and under the Trademarks, together with, among other things, the goodwill of the business symbolized by the Trademarks and the applications and registrations thereof, and all proceeds thereof, including, without limitation, any and all causes of action arising prior to or after the date hereof for infringement thereof and any and all damages arising from past, present and future violations thereof (the "Collateral"), to secure the payment, performance and observance of the Secured Obligations and in the event any provisions in this Assignment for Security are deemed to conflict with the Security Agreement, the provisions of the Security Agreement shall govern:

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the Assignor does hereby grant to the Assignee for the benefit of the Secured Parties a continuing security interest in the Collateral to secure the prompt payment, performance and observance of the Secured Obligations.

The Assignor does hereby further acknowledge and affirm that the rights and remedies of the Assignee with respect to the Collateral are more fully set forth in the Security Agreement, the terms and provisions of which are hereby incorporated herein by reference as if fully set forth herein.

If Assignor shall obtain any new Collateral, the provisions of this Assignment for Security shall automatically apply thereto. Assignor shall give notice in writing to Assignee with respect to any such new Collateral or any renewal or extension thereof as required in accordance with the Credit Agreement (as defined in the Security Agreement). Without limiting Assignor's obligations under this Section, Assignor hereby authorizes Assignee unilaterally to modify this Assignment for Security by amending Schedule 1A to include any such new Collateral of Assignor. Notwithstanding the foregoing, no failure to so modify this Assignment for Security or amend Schedule 1A shall in any way affect, invalidate or detract from Agent's continuing security interest in all Collateral, whether or not listed on Schedule 1A.


