**RELEASE OF SUPPLEMENTAL INTELLECTUAL PROPERTY SECURITY
AGREEMENT**

This RELEASE dated as of April 11, 2022 is made by HSBC Bank USA, National Association, as Collateral Agent for the Secured Parties (in such capacity, the “Collateral Agent”), in favor of eBags, LLC., a Delaware limited liability company, and Galaxy Media, LLC, a Nevada limited liability company (the “Grantors”). All capitalized terms used herein that are not otherwise defined herein shall have the respective meanings ascribed thereto in the Supplemental IP Security Agreement, IP Security Agreement, and the Amended and Restated Credit Agreement, as applicable, as described below.

Reference is made to: (a) the Amended and Restated Credit Agreement, dated as of April 25, 2018 (the “Credit Agreement”), among Samsonite International S.A., a *société anonyme* (public limited liability company) governed by the laws of the Grand-Duchy of Luxembourg, having its registered office at 13-15 avenue de la Liberté, L-1931 Luxembourg, registered with the Luxembourg Register of Commerce and Companies (*Registre de Commerce et des Sociétés, Luxembourg*) under number B 159469 (sometimes hereinafter referred to as the “Borrower”), HSBC Bank USA, National Association, as TLA and Revolver Administrative Agent (together with its permitted successors in such capacity, “TLA and Revolver Administrative Agent”) and as Collateral Agent (together with its permitted successors in such capacity, “Collateral Agent”), and Bank of America N.A., as TLB Administrative Agent (together with its permitted successors in such capacity, “TLB Administrative Agent” and together with the TLA and Revolver Administrative Agent, the “Administrative Agents”); (b) the Intellectual Property Security Agreement, dated as of June 23, 2017 (the “Security Agreement”), between eBags, LLC., a Delaware limited liability company, and the Collateral Agent, and (3) the Supplemental Intellectual Property Security Agreement, dated as of April 25, 2018 (the “Supplemental Security Agreement”), between the Grantors and the Collateral Agent.

Pursuant to the Supplemental Security Agreement, the Grantors granted a security interest to the Collateral Agent, for its benefit and the benefit of the Secured Parties, in certain Collateral (as defined in Section 1 to the Supplemental Security Agreement) of the Grantors, including but not limited to that set forth on Schedule I hereto (the “Collateral”), which security interest was recorded with the United States Patent & Trademark Office under Reel/Frames 6332/0202 on May 17, 2018 6356/0821 on April 27, 2018, with respect to the trademark set forth on Schedule I hereto.

It has been determined that the Collateral identified in Schedule I hereto was not properly identified as it was not an asset owned by Galaxy Media, LLC, the inclusion of the Collateral was improper, and the recordation of the security interest at the States Patent & Trademark Office with respect to the Collateral was in error.

Based on this, Grantors have informed the Collateral Agent of their desire to obtain the release of all rights, title and interest of the Collateral Agent in and to the Collateral granted under the Supplemental Security Agreement.

Accordingly, for good and valuable consideration, receipt of which is acknowledged, the Collateral Agent hereby releases all rights, title and interest (including, without limitation, security interests) in and to the Collateral, except to the extent that any expense reimbursement, indemnification or other provision of any of the Supplemental Security Agreement expressly survives termination of the Supplemental Security Agreement.

Upon the reasonable request of the Grantors, the Collateral Agent will provide, at the Grantors' expense, the Grantors with any information and additional authorization reasonably effect the release of the Collateral Agent's security interest in the Collateral.

IN WITNESS WHEREOF, the Collateral Agent, by its duly authorized officer thereof, has caused this Release to be duly executed as of the date set forth above.
