**INTELLECTUAL PROPERTY RIGHTS
ASSIGNMENT AGREEMENT**

This Intellectual Property Rights Assignment Agreement (the "**Agreement**") is concluded on October 15, 2021 (the "**Effective Date**") between:

(A) **Kemira Chemicals, Inc.**

("Assignor")

and

(B) **Kemira Oyj**

Address: Energiakatu 4, 00180 Helsinki, Finland

Business ID 0109823-0

("Assignee")

Assignor and Assignee are jointly referred to as the "**Parties**" and each separately a "**Party**".

BACKGROUND:

- A. The Assignee is the ultimate parent company of Kemira group. The Assignor is an affiliated company of the Assignee.
- B. The Assignor is the sole legal and beneficial owner of certain intellectual property rights and the corresponding registrations set forth in Exhibit A attached hereto (the "**Assigned IPR**").
- C. The Assignor desires to sell, and the Assignee desires to purchase, the legal and beneficial ownership of the Assigned IPR on terms and conditions set out in this Agreement.

THE PARTIES HEREBY AGREE AS FOLLOWS:

1 Assignment

- 1.1 Assignor hereby irrevocably sells and assigns to Assignee all of Assignor's right, title and interest in and to Assigned IPR, including without limitation any and all associated goodwill (beneficial ownership), together with all rights of action and claims for damages and benefits for Assignee's own risk and account arising because of past

infringement thereof, and Assignee agrees to purchase the Assigned IPR and accepts such assignment. The assignment includes, without limitation, the right to sue and recover for any past or continuing infringements or contract breaches related to the Assigned IPR, the right to renew any registrations included in the Assigned IPR, the right to apply for registrations based in whole or in part upon the Assigned IPR, and any priority right that may arise from the Assigned IPR.

1.2 The full and unrestricted beneficial ownership of the Assigned IPR shall pass from the Assignor to the Assignee upon the Effective Date. As of the Effective Date, the Assignee is entitled to exercise all rights attached or accruing to the beneficial ownership of the Assigned IPR.

1.3 The Assignor authorizes the United States Patent and Trademark Office and any other applicable jurisdictions outside the United States to record the transfer of the registrations and/or registration applications related to the Assigned IPR to Assignee as the recipient of Assignor's entire right, title, and interest therein.

2 Purchase Price and Payment

2.1 Purchase price

The Assigned IPR has been a part of a cost sharing arrangement between the Parties. As consideration for the transfer of the ownership of the Assigned IPR, Assignee agrees to reimburse Assignor for any documented registration or administrative costs relating to the Assigned IPR incurred by Assignor between January 1, 2011 and October 15, 2021.

Assignor shall notify Assignee of such costs in writing by the end of this year and issue an invoice for the same with a payment term of not less than 14 days.

2.2 Payment

The Assignee agrees to pay the purchase price to the Assignor according to the invoice to be issued by Assignor. The purchase price will be paid in cash in immediately available funds by means of a bank transfer to the bank account indicated by the Assignor and/or through setting off against receivables held by the Assignee from the Assignor utilizing the Kemira Group Netting System. Interest on overdue payments under this Agreement shall accrue in accordance with the Finnish Interest Act (633/1982) (as amended from time to time).

3 Use of the Assigned IPR by Assignor after the assignment

Assignor may continue exploiting the Assigned IPR in accordance with the existing License Agreement between Assignee and Assignor dated January 1, 2009.

4 Representations and Warranties of the Assignor

The Assignor represents and warrants to the Assignee that the representations and warranties given in this clause 4 shall be true as at the date hereof.

4.1 Validity of this Agreement

This Agreement has been duly authorized and approved by the Assignor and constitutes a legal, valid and binding obligation of the Assignor enforceable against it in accordance with its terms.

The Assignor has the full legal and corporate power to enter into this Agreement and to consummate the transaction.

Neither the execution of this Agreement nor the consummation of the Transaction will result in a breach of any judgment, decree or order of any national or supranational court, governmental or other body, any applicable law or regulation or the articles of association of the Assignor.

4.2 Transfer of beneficial ownership

The Assignor has full right, power and authority to convey the beneficial ownership of the Assigned IPR in accordance with this Agreement. The beneficial ownership is not subject to any kind of encumbrance, lien or any other third party right.

5 Representations and Warranties of the Assignee

The Assignee represents and warrants to the Assignor that the representations and warranties given in this clause 5 shall be true as at the date hereof.

5.1 Validity of this Agreement

This Agreement has been duly authorized and approved by the Assignee and constitutes a legal, valid and binding obligation of the Assignee enforceable against it in accordance with its terms.

The Assignee has the full legal and corporate power to enter into this Agreement and to consummate the Transaction. Neither the execution of this Agreement nor the consummation of the Transaction will result in a breach of any judgment, decree or order of any national or supranational court, governmental or other body, any applicable law or regulation or the Articles of Association of the Assignee.

6 Confidentiality

Unless otherwise required by applicable law, the Parties shall maintain secret and confidential and shall not publicly disclose the contents of this Agreement.

7 Miscellaneous

7.1 Taxes and fees related to the transfer

All taxes and any related fees potentially levied on this transaction, whether in Finland or in any other jurisdiction, shall be paid by the Assignee. The Assignee shall, at its own expense, properly file on a timely basis all necessary transfer tax and other documentation with respect to any transfer tax and other applicable tax and fee and provide the Assignor with evidence of payment thereof.

7.2 Further assurances

Each Party undertake that it shall, from time to time, do or procure the doing of all acts and/or execute or procure the execution of all documents, as may be reasonably required for the conclusion and implementation of this transaction.

7.3 Entire Agreement

This Agreement represents the entire understanding and agreement between the Parties with respect to the subject matter hereof and supersedes all prior negotiations, understandings and agreements relating to the subject matter hereof.

7.4 Amendments

Any amendment to this Agreement shall be in writing and shall have no effect unless signed by the duly authorized representatives of both Parties.


7.5 Governing law and dispute resolution

This Agreement shall be governed by and construed in accordance with the laws of Finland. Any dispute, controversy or claim arising out of or relating to this Agreement, or the breach, termination or validity thereof shall be finally settled by arbitration in accordance with the Arbitration Rules of Finland Chamber of Commerce in in Helsinki, Finland.



