CONFIRMATION OF TRADEMARK ASSIGNMENT

NOW, THEREFORE, Cisco and CTI confirm that:


"**Cisco Marks**" means all of Cisco's trademarks, service marks, trade names, trade dress, logos, designs and slogans, in word mark, stylized and/or design formats, including without limitation Cisco's trademark registrations and applications and any and all of Cisco's common law rights in the aforementioned items, together with all goodwill associated with and symbolized by the aforementioned items, including without limitation the marks identified in Schedule 1 attached hereto and all of the goodwill associated with and symbolized by such marks.

Effective June 30, 2021, Cisco has assigned and transferred, and CTI received and accepted, all of Cisco's rights, title and interest throughout the world in and to the Cisco Marks and all the rights, claims and privileges pertaining to the Cisco Marks, including without limitation: the registrations and applications pertaining thereto, together with all of the goodwill of the business associated with and symbolized by the Cisco Marks; and the right to sue and recover damages for past, present and future infringements thereof and to stand in the place of Cisco in all matters related thereto.

Cisco hereby authorizes and requests the United States Commissioner of Patents and Trademarks and the relevant officials of foreign jurisdictions to implement this Assignment.


