**TERMINATION AND RELEASE  
OF SECURITY INTEREST IN TRADEMARKS**

This **TERMINATION AND RELEASE OF SECURITY INTEREST IN TRADEMARKS** (this “*Release*”) is executed as of July 21, 2022 by Citizens Bank, N.A., previously known as RBS Citizens, N.A., a national banking association, having an address of 28 State Street, Boston, MA 02109 (“*Lender*”) in favor of Harrison Global LLC, a Massachusetts limited liability company, MTG Acquisitions LLC, a Massachusetts limited liability company, and DDSSBOS LLC, a Massachusetts limited liability company, all with a place of business at 224 Calvary Street, Waltham, MA 02453 (the “*Released Parties*”).

**WHEREAS**, pursuant to the terms of that certain Supplemental Trademark Security Agreement dated July 16, 2013, by and between Lender and Harrison Global LLC, as filed with the United States Patent and Trademark Office (“*USPTO*”) on August 2, 2013, Harrison Global LLC granted to the Lender a security interest in and lien on its trademarks identified on Schedule A attached hereto (the “*Trademark Collateral 1*”), which security interest is recorded with the USPTO at Reel 005082, Frame 0591;

**WHEREAS**, pursuant to the terms of that certain Supplemental Trademark Security Agreement dated March 18, 2014, by and between Lender and MTG Acquisitions LLC, as filed with the USPTO on March 24, 2014, MTG Acquisitions LLC granted to the Lender a security interest in and lien on its trademarks identified on Schedule A attached hereto (the “*Trademark Collateral 2*”), which security interest is recorded with the USPTO at Reel 005242, Frame 0678;

**WHEREAS**, pursuant to the terms of that certain Security and Pledge Agreement dated as of April 18, 2014, by and among Lender and the grantors thereto, as evidenced by a Notice of Grant of Security Interest in Trademarks by the Lender and Harrison Global LLC filed with the USPTO on April 23, 2014, Harrison Global LLC granted to the Lender a security interest in and lien on its trademarks identified on attached hereto (the “*Trademark Collateral 3*”), which security interest is recorded with the USPTO at Reel 005267, Frame 0027;

**WHEREAS**, pursuant to the terms of that certain Amended and Restated Security and Pledge Agreement dated as of November 28, 2017 by and among the Lender and the grantors thereto, as evidenced by a Notice of Grant of Security Interest in Trademarks by the Lender, MTG Acquisitions LLC and DDSSBOS LLC filed with the USPTO on November 28, 2017, MTG Acquisitions LLC and DDSSBOS LLC granted to the Lender a security interest in and lien on their trademarks identified on Schedule A attached hereto (the “*Trademark Collateral 4*”, and collectively with Trademark Collateral 1, Trademark Collateral 2 and Trademark Collateral 3, the “**Trademark Collateral**”), which security interest is recorded with the USPTO at Reel 006214, Frame 0571;

**WHEREAS**, the Lender wishes to release the security interest in and lien on the Trademark Collateral.

**NOW, THEREFORE**, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the Lender states as follows:

The Lender hereby terminates, releases, and discharges its security interest in and lien on the Trademark Collateral, and the Lender hereby assigns and transfers to the Released Parties without recourse or representation or warranty, express or implied, of any kind, all of its right, title and interest in and to the Trademark Collateral, effective as of the date set forth above.


