**FIRST AMENDMENT TO CONFIRMATORY GRANT OF SECURITY INTEREST IN INTELLECTUAL PROPERTY**

THIS FIRST AMENDMENT TO CONFIRMATORY GRANT OF SECURITY INTEREST IN INTELLECTUAL PROPERTY (this "Amendment"), is made and entered into effective as of July 22, 2022, by and between MANAGEMENT CONTROLS, INC., a Texas corporation ("Grantor") and CIBC BANK USA, an Illinois banking corporation ("Lender"). Unless otherwise defined herein, all capitalized terms used herein shall have the respective meanings assigned to such terms in the Confirmatory Grant (as defined below).

WHEREAS, Grantor and Lender are parties to that certain Loan and Security Agreement, dated as of March 31, 2021, as amended by that certain First Amendment to Loan and Security Agreement, dated as of December 23, 2021, and as further amended by that certain Second Amendment to Loan and Security Agreement dated as of even date herewith (as the same may be amended, restated, supplemented or modified from time to time, the "Loan Agreement").

WHEREAS, Grantor and Lender entered into that certain Confirmatory Grant of Security Interest in Intellectual Property, dated as of March 31, 2021 (as amended, restated, supplemented or otherwise modified from time to time, the "Confirmatory Grant").

WHEREAS, Grantor and Lender desire to amend the Confirmatory Grant in accordance with the terms and conditions of this Amendment.

NOW, THEREFORE, in consideration of the premises set forth above and for other good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged, the undersigned parties agree as follows:

1. Incorporation of the Confirmatory Grant. All capitalized terms which are not defined hereunder shall have the same meanings as set forth in the Confirmatory Grant. Except as specifically set forth herein, the Confirmatory Grant shall remain in full force and effect and its provisions shall be binding on the parties hereto. All references to "this Confirmatory Grant" and similar terms in the Confirmatory Grant shall mean the Confirmatory Grant as amended hereby.

2. Amendment to the Confirmatory Grant. Subject to the terms and conditions set forth in this Amendment, the parties hereto hereby amend the Confirmatory Grant as follows:

(a) Exhibit B (Trademarks) of the Confirmatory Grant is here by amended by adding the information included on Exhibit A attached hereto.

3. Effectuation. The amendment to the Confirmatory Grant contemplated by this Amendment shall be deemed effective immediately upon the full execution of this Amendment and without any further action required by the parties hereto. There are no conditions precedent or subsequent to the effectiveness of this Amendment.

4. Counterparts. This Amendment may be signed in one or more counterparts, but all of such counterparts taken together shall constitute and be deemed to be one and the same

instrument. A signature hereto sent or delivered by facsimile or other electronic transmission shall be as legally binding and enforceable as a signed original for all purposes.




