TRADEMARK SECURITY AGREEMENT

THIS TRADEMARK SECURITY AGREEMENT, dated as of July 19, 2022 (as it may be amended, restated, amended and restated, supplemented and/or modified from time to time the “Agreement”), is made by the entities listed on the signature page hereof (each, a “Grantor” and collectively the “Grantors”), in favor of **MS PRIVATE CREDIT ADMINISTRATIVE SERVICES LLC**, as administrative agent (in such capacity, together with its successors and permitted assigns, the “Administrative Agent”) for the Lender Parties (as defined in the Loan Agreement referred to below).

WITNESSETH:

WHEREAS, pursuant to that certain Loan and Security Agreement, dated as of July 19, 2022 (as the same may be amended, restated, amended and restated, supplemented and/or modified from time to time, the “Loan Agreement”), by and among the financial institutions that are or may from time to time become parties thereto as Lenders, the Administrative Agent, **REVOLUTION FOODS, PBC**, a Delaware public benefit corporation, doing business in California as Revolution Foods (“Revolution Foods”), **BALANCE FOODS, LLC**, a California limited liability company (“Balance Foods”), **MORENO BROS. DISTRIBUTING, LLC**, a California limited liability company (“Moreno”, and together with Revolution Foods and Balance Foods, each a “Borrower” and collectively the “Borrowers”), Revolution Foods as Borrower Representative and the other Loan Parties from time to time party thereto, the Lenders have agreed to make extensions of credit to the Borrowers upon the terms and subject to the conditions set forth therein.

In consideration of the premises and to induce the Lenders and Administrative Agent to enter into the Loan Agreement and to induce the Lenders to make their respective extensions of credit to the Borrowers thereunder, each Grantor hereby agrees with Administrative Agent as follows:

Section 1. Defined Terms. Capitalized terms used herein without definition are used as defined in the Loan Agreement.

Section 2. Confirmation of Grant of Security Interest in Trademark Collateral. Each Grantor, as collateral security for the prompt and complete payment and performance when due (whether at stated maturity, by acceleration or otherwise) of the Obligations of each Grantor, granted to Administrative Agent for the benefit of the Lender Parties a security interest in all of its right, title and interest in, to and under all of its Trademarks, including those referred to on Schedule 1 hereto, pursuant to the terms of the Loan Agreement.

Section 3. Loan Agreement. Each Grantor hereby acknowledges and agrees that the rights and remedies of Administrative Agent with respect to the security interest in the Collateral are more fully set forth in the Loan Agreement.

Section 4. Recordation. Each Grantor authorizes the Commissioner for Trademarks to record and register this Agreement upon request by Administrative Agent.

Section 5. Counterparts. This Agreement may be executed in any number of counterparts and by different parties in separate counterparts, each of which when so executed shall be deemed to be an original and all of which taken together shall constitute one and the same

agreement. Signature pages may be detached from multiple separate counterparts and attached to a single counterpart.

Section 6. Successors and Assigns. This Agreement will be binding on and shall inure to the benefit of the parties hereto and their respective successors and permitted assigns.

Section 7. Applicable Law. This Agreement, the rights and obligations of the parties hereto, and all claims or causes of action (whether in contract, tort or statute) that may be based upon, arise out of or relate to this Agreement, or the negotiation, execution or performance of this Agreement (including any claims or causes of action based upon, arising out of or related to any representation or warranty made in or in connection with this Agreement), shall be governed by, and shall be construed and enforced in accordance with, the internal laws of the State of New York without regard to any laws, rules or provisions of the State of New York that would cause the application of the laws of any jurisdiction other than the State of New York.
