

This Assignment is binding on the Assignor and his successors and assigns, and inures to the benefit of the Assignee and its successors and assigns. This Assignment may be executed in any number of counterparts, each of which shall be deemed an original, and all of which, taken together, shall constitute one and the same instrument. Documents executed, scanned, and transmitted electronically and electronic signatures shall be deemed original signatures for purposes of this Assignment and all matters related thereto, with such scanned and electronic signatures having the same legal effect as original signatures. This Assignment shall be governed under the laws of the State of New York. In the event that any provision of this Assignment is held to be invalid, illegal, or unenforceable by a court of competent jurisdiction, such holding shall in no way affect the validity, legality, or enforceability of any other provision of this Assignment.


