RELEASE OF SECURITY INTEREST IN TRADEMARKS

For good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged, effective as of July 19, 2022, American National Bank and Trust Company of Chicago, a national banking association having a principal place of business at 10 S. Dearborn St. Chicago IL 60603 ("American") and JPMorgan Chase Bank, N.A. (as successor in interest to Banc One Leasing Corporation), a ~~Delaware corporation~~ having a principal place of business at 10 South Dearborn, Chicago, IL 60603 ("JPMC," together with American, the "Secured Parties"), do hereby certify that the continuing security interest they hold in all property of the Debtor, including without limitation all "Intellectual Property" (as that term is defined in the Security Agreement, defined below) of Whiting Corporation, a Delaware corporation having a principal place of business at 26000 S. Whiting Way, Monee, IL 60449 (the "Debtor") granted to the Secured Parties pursuant to the Security Agreement dated August 2, 2002, by and among Grantor and Secured Parties, which was recorded in the United States Patent and Trademark Office on November 8, 2002 at Reel 2617, Frame 0843 and in the Canadian Intellectual Property Office on December 5, 2002 (the "Security Agreement"), which was entered into pursuant to (i) that certain Reimbursement Agreement dated June 1, 2000 (as amended, amended and restated, supplemented, restructured or otherwise modified, renewed or replaced from time to time, the "Reimbursement Agreement") among Debtor and American and (ii) that certain Master Lease Agreement dated June 9, 1998 (as amended, amended and restated, supplemented, restructured or otherwise modified, renewed or replaced from time to time, the "Master Lease Agreement") among Debtor and JPMC, which Intellectual Property is identified on Schedule A annexed hereto and made a part hereof, together with the goodwill of the business symbolized thereby, is hereby released, relinquished and discharged with respect to Grantor and all right, title and interest in such Intellectual Property previously assigned to Secured Parties under the Security Agreement is hereby reassigned to Grantor, without representation or warranty of any kind, nature or description. The Secured Parties hereby authorizes the Grantor, or the Grantor's authorized representatives to record this Release with the United States Patent and Trademark Office, the Canadian Intellectual Property Office and/or any other applicable governmental office or agency. The Secured Parties agrees to execute and deliver to the Grantor, at the Grantor's expense, all other instruments and other documents as may be reasonably necessary or proper to release the security interest in the Intellectual Property which had been granted under the Security Agreement.
