FIRST AMENDMENT TO INTELLECTUAL PROPERTY SECURITY AGREEMENT

This **FIRST AMENDMENT TO INTELLECTUAL PROPERTY SECURITY AGREEMENT**, dated as of August 8, 2022 (the "**Amendment**"), is entered into by and between **WESTERN ALLIANCE BANK**, an Arizona corporation ("**Lender**"), and **SILKROAD TECHNOLOGY, INC.**, a Delaware corporation ("**Grantor**").

RECITALS

A. On September 15, 2021, Lender and Grantor entered into that certain Intellectual Property Security Agreement (the "**Agreement**"), pursuant to which Grantor granted to Lender a security interest in certain Copyrights, Trademarks and Patents to secure the obligations of Grantor in connection with that certain Loan and Security Agreement by and between Lender and Grantor, dated as of September 15, 2021 (as the same may be amended, modified or supplemented from time to time, the "**Loan Agreement**"; capitalized terms used herein are used as defined in the Loan Agreement).

B. Lender and Grantor desire to amend Exhibit B to the Agreement to add certain additional Trademarks not previously included on such Exhibit B.

C. Lender and Grantor desire to amend Exhibit C to the Agreement to add certain additional Patents not previously included on such Exhibit C.

NOW, THEREFORE, for good and valuable consideration, receipt of which is hereby acknowledged, Grantor hereby covenants and agrees as follows:

AGREEMENT

Exhibit B to the Agreement is hereby deleted in its entirety and replaced with Exhibit B attached hereto.

Exhibit C to the Agreement is hereby deleted in its entirety and replaced with Exhibit C attached hereto.

Except as set forth in this Amendment, all terms and provisions of the Agreement are hereby ratified and confirmed and shall be and remain unmodified and in full force. This Amendment supersedes any other purported modification of the Agreement, whether or not executed by the parties or any of them.

This Amendment may be executed in two or more counterparts, each of which shall be deemed an original but all of which together shall constitute the same instrument.
