REASSIGNMENT AND RELEASE OF SECURITY INTEREST

This Reassignment and Release of Security Interest (this “*Reassignment and Release*”) is made as of August 18, 2022, by WESTERN ALLIANCE BANK, an Arizona corporation (“*Bank*”) in favor of STEP MOBILE, INC., a Delaware corporation (“*Grantor*”).

RECITALS

WHEREAS, Grantor granted to Bank a security interest in its trademarks, including without limitation its trademarks described on Exhibit B (collectively, the “*Trademarks*”), under an Intellectual Property Security Agreement dated as of August 11, 2020 (as may be amended, restated, supplemented or otherwise modified, the “*Agreement*”), and recorded with the US Patent and Trademark Office as set forth on Exhibit B. All capitalized terms used in this Reassignment and Release and not otherwise defined herein have the meaning given in the Security Agreement.

WHEREAS, Grantor has no outstanding obligations to Bank under the terms of the Security Agreement, and Bank agrees to release its security interest in the Trademarks.

AGREEMENT

Now therefore, Bank terminates, discharges, cancels, and releases its security interest in the Trademarks and reassigns to Grantor, without warranty or recourse, all interest of Bank in the Trademarks. Bank hereby terminates, without representation or warranty of any kind, the Security Agreement. Bank will take all further actions, and provide Grantor and its successors, assigns, or other legal representatives, all such cooperation and assistance reasonably requested by Grantor, at Grantor’s sole cost and expense, to more fully and effectively effectuate the purposes of this Reassignment and Release.
