RELEASE OF TRADEMARK SECURITY AGREEMENT

THIS RELEASE OF TRADEMARK SECURITY AGREEMENT, dated as of July 21, 2022, (this “Release”) is made by MONROE CAPITAL MANAGEMENT ADVISORS, LLC, as Administrative Agent (the “Administrative Agent”) under the Trademark Security Agreement (as amended, supplemented or modified and in effect from time to time, the “Trademark Security Agreement”), between CREDIT SWAG VENTURES, INC., a Montana corporation (the “Grantor”) and the Administrative Agent. Capitalized terms used but not defined herein have the meanings provided in the Trademark Security Agreement.


WHEREAS, pursuant to the Trademark Security Agreement which was recorded at the United States Patent and Trademark Office on July 1, 2022, the Grantor granted to the Administrative Agent a continuing security interest in the Grantor’s right, title and interest in Trademarks, including those set forth on the attached Schedule I, together with the goodwill of the business symbolized by the Grantor’s Trademarks.

WHEREAS, Grantor has requested and the Administrative Agent has agreed to provide a document suitable for recording in the United States Patent and Trademark Office evidencing and effecting the release, relinquishment and discharge of its security interest in the Trademark Collateral (the “Released Collateral”).


NOW, THEREFORE, for good and valuable consideration, the receipt of which is hereby acknowledged, the Administrative Agent does hereby, in each case, without recourse, representation or warranty of any kind whatsoever, (a) terminate the liens and security interest created under the Trademark Security Agreement in the Released Collateral, (b) release its security interest in the Released Collateral, (c) discharge any and all rights, title and interest it has in and the security interest granted to the Administrative Agent in the Released Collateral, and (d) reassigns, grants and conveys to the Grantor any and all right, title and interest the Grantor has in the Released Collateral.
