**RELEASE OF SECURITY INTEREST IN TRADEMARKS**

This **RELEASE OF SECURITY INTEREST IN TRADEMARKS** (the “Release”) is made as of July 19, 2022, by TIKEHAU INVESTMENT MANAGEMENT, as Security Agent for the Beneficiaries (in such capacity, together with its successors and permitted assigns, the “Security Agent”), in favor of C & K COMPONENTS, LLC, a Delaware limited liability company (“Grantor”).

**W I T N E S S E T H**

WHEREAS, pursuant to that certain U.S. Trademark Security Agreement, dated as of May 28, 2020 (as amended, modified, extended, restated, replaced, or supplemented from time to time, the “Trademark Security Agreement”) by Grantor in favor of the Security Agent, Grantor granted to the Security Agent a security interest in and continuing lien on Grantor’s right, title and interest in, to and under the Trademark Collateral (as defined in the Trademark Security Agreement), including, without limitation, the Trademarks identified on Schedule 1 attached hereto (the “Trademarks”);

WHEREAS, the Trademark Security Agreement was recorded with the U.S. Patent and Trademark Office with respect to Trademarks on May 28, 2020 at Reel 6948, Frame 0231;

WHEREAS, Grantor requests a release of the Trademark Collateral, including, without limitation, the Trademarks; and

WHEREAS, the Security Agent desires to terminate and grant a release of the Trademark Collateral, including, without limitation, the Trademarks, as provided in this Release.


NOW THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the Security Agent does hereby agree as follows:

1. The Security Agent hereby (a) terminates the Trademark Security Agreement, (b) releases, relinquishes, terminates and discharges the Trademark Collateral in its entirety and (c) reassigns to Grantor any and all right, title and interest of any nature whatsoever which it may hold in or to the Trademark Collateral (including, without limitation, the Trademarks identified on Schedule 1 attached hereto).
2. The Security Agent hereby (a) authorizes Grantor and its successors, assigns or other legal representatives to file this Release with the U.S. Patent and Trademark Office to evidence and effectuate the release and termination of the Security Agent’s security interest in the Trademark Collateral and (b) authorizes the Commissioner for Trademarks to record and register this Release.
3. At the reasonable request and sole expense of Grantor, the Security Agent agrees to execute, acknowledge and deliver all such further instruments and to take all such further actions necessary to carry out the purposes of this Release.
4. Delivery of an executed signature page of this Release by facsimile or electronic transmission (e.g., email of a PDF file) shall be as effective as delivery of a manually executed counterpart hereof. The words “executed,” “signed,” “signature,” and words of like import in this Release shall be deemed to include electronic signatures or electronic records, each of which shall be of the same legal effect, validity or enforceability as a manually executed signature or the use of a paper-based recordkeeping system, as the case may be, to the extent and as provided for in any applicable law, including the Federal Electronic Signatures in Global and National Commerce Act, the New York State Electronic Signatures and Records Act, or any other similar state laws based on the Uniform Electronic Transactions Act.
