**TERMINATION AND RELEASE OF  
SECURITY AGREEMENT (TRADEMARKS)**

This TERMINATION AND RELEASE OF SECURITY AGREEMENT (TRADEMARKS) (this "Termination"), dated as of July 25, 2022, is executed by NORTH ATLANTIC VENTURE FUND V, L.P., a Delaware limited partnership ("Purchaser"), and Chartbeat, Inc., a Delaware corporation ("Borrower"). All capitalized terms used in this Termination and not otherwise defined herein, shall have the respective meanings given to such terms in the Security Agreement (Trademarks) (defined below).

RECITALS

A. Pursuant to that certain Security Agreement (Trademarks), dated as of June 29, 2018, an extension to that certain Loan and Security Agreement, dated as of June 29, 2018 (the "Security Agreement"), by and between Borrower and Purchaser, Borrower granted to Purchaser a security interest in certain Marks set forth on Exhibit A attached hereto (which includes Marks that were applied for or registered after execution of the Security Agreement).

B. The Security Agreement was recorded with the Trademark Division of the United States Patent and Trademark Office at Reel/Frame 006368/0616.

C. Purchaser agrees to execute this Termination in order to evidence the termination and release of its security interest in the Marks listed in the Security Agreement.

AGREEMENT

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged, Purchaser hereby expressly terminates and releases all of Purchaser's security interest in all of Borrower's right, title and interest in, to and under its intellectual property (including without limitation those Marks listed in Exhibit A attached to the Security Agreement), and including without limitation all proceeds thereof (such as, by way of example but not by way of limitation, license royalties and proceeds of infringement suits), the right to sue for past, present and future infringements, all rights corresponding thereto throughout the world and all renewals thereof. Purchaser hereby agrees to duly execute, acknowledge, procure and deliver any further documents and to do such other acts as may be necessary to effect the release of the security interest in the Marks contemplated hereby.
