2. Upon Assignee's request, Assignor shall promptly: (a) take such actions and execute such documents which may be required worldwide to effectuate this assignment and (b) provide whatever assistance to Assignee that Assignee may reasonably request from time to time to perfect this assignment and record the transfer worldwide.
