**RELEASE OF SECURITY INTEREST
IN INTELLECTUAL PROPERTY COLLATERAL**

This RELEASE OF SECURITY INTEREST IN INTELLECTUAL PROPERTY COLLATERAL (this “Release”), dated as of July 27, 2022, is made by Glas Americas LLC, a Delaware limited liability company, as collateral agent (the “Collateral Agent”) and Glas USA LLC, a New Jersey limited liability company, as administrative agent (the “Administrative Agent”, and together with the Collateral Agent, the “Agents”), in favor of AgileThought, Inc. (f/k/a AN Global, Inc.), a Delaware corporation, AN USA, a California corporation, 4th Source, LLC, a Delaware limited liability company and Agilethought, LLC, a Florida limited liability company (each, a “Grantor”, and collectively, the “Grantors”).

RECITALS

WHEREAS, the Grantors and the Agents entered into a that certain Guaranty and Collateral Agreement, dated as of July 18, 2019 (the “Agreement”);

WHEREAS, pursuant to the Agreement, the Grantors granted to the Agents a security interest in all of the Grantors’ right, title and interest, whether presently existing, or after acquired, in, to and under all of the Collateral;

WHEREAS, in connection with the Agreement, the Grantors and the Agents entered into a certain Trademark Security Agreement, dated as of July 18, 2019 and recorded at Reel/Frame No. 006703/0229 (trademark) (the “IP Security Agreement”);

WHEREAS, pursuant to the IP Security Agreement, the Grantors granted to the Agents a security interest in all of Grantors’ right, title and interest in, to and under its intellectual property (including without limitation those Trademarks listed on Schedule 1 to the IP Security Agreement), and including without limitation all proceeds thereof, the right to sue for past, present and future infringements, all rights corresponding thereto throughout the world and all re-issues, divisions, continuations, renewals, extensions and continuations-in-part thereof (collectively, the “Intellectual Property Collateral”);

WHEREAS, pursuant to Section 2(f) of that certain pay-off letter dated August 23, 2021 addressed to AgileThought, Inc. and AN Extend, S.A. DE C.V. from the Agents and the Lenders (as defined in such Pay-Off Letter) (the “Pay-Off Letter”) the Agents are executing this Release;

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged, the Agents agree as follows:

1. The IP Security Agreement is hereby terminated, and accordingly, the Agents (i) release, discharge and cancel any and all liens, security interests, right, title, and interest, in the Intellectual Property Collateral and (ii) reassign, grant and convey to the Grantors any and right, title, and interest, in the Intellectual Property Collateral.

2. The Agents claim no right, title or interest whatsoever in or to any of the Intellectual Property Collateral.

3. The Agents authorize the recordation of this Release with the United States Patent and Trademark Office.

4. Capitalized terms used herein and not otherwise defined shall have the meanings ascribed thereto in the Agreement.
