**RELEASE OF SECURITY INTEREST IN TRADEMARKS**

This RELEASE OF SECURITY INTEREST IN TRADEMARKS (this "Release") is effective as of July 22, 2022, and is given by COÖPERATIEVE RABOBANK U.A., NEW YORK BRANCH (f/k/a Coöperatieve Centrale Raiffeisen-Boerenleen Bank B.A., "Rabobank Nederland", New York Branch), in its capacity as administrative agent for the Secured Parties ("Administrative Agent"), with its principal offices at 245 Park Avenue, New York, New York 10167, in favor of WAYNE FARMS LLC, a Delaware limited liability company ("Grantor"). Capitalized terms not defined herein shall have the meanings given to them, directly or by reference, in the Trademark Security Agreement (as defined below).

WHEREAS, pursuant to that certain Second Amended and Restated Pledge and Security Agreement, dated as of August 30, 2013, by and among the Administrative Agent, the Grantor and certain other parties (as may have been amended, restated, amended and restated, supplement or otherwise modified from time to time, the "Security Agreement"), the Grantor executed and delivered that certain Trademark Security Agreement in favor of the Administrative Agent and dated as of August 30, 2013 (the "Trademark Security Agreement"), which was recorded in the Assignment Division of the United States Patent & Trademark Office on September 3, 2013 at Reel 5102, Frame 0579;

WHEREAS, pursuant to the Security Agreement and the Trademark Security Agreement, the Grantor granted and pledged to the Administrative Agent, for the ratable benefit of the Secured Parties, a Security Interest (the "Security Interest") in the Trademark Collateral, including without limitation, those items listed on Schedule 1 hereto; and

WHEREAS, Administrative Agent now desires to release the entirety of its Security Interest in the Trademark Collateral.

NOW, THEREFORE, for good and valuable consideration, receipt of which is hereby acknowledged, Administrative Agent hereby (i) terminates, releases, and discharges the Security Interest in the Trademark Collateral, and (ii) re-assigns to the Grantor any right, title or interest it may have in the Trademark Collateral, in each case without recourse to the Secured Party and without representation or warranty of any kind. The Administrative Agent further agrees to execute and deliver to the Grantor any and all further documents and instruments, and do any and all further acts which the Grantor (or their agents or designees) reasonably request (at the Grantor's sole cost and expense) in order to confirm this release and the Grantor's right, title and interest in, to and under the Trademark Collateral, including, without limitation, those items listed on Schedule 1 hereto. The Administrative Agent hereby authorizes the Grantor, or any successor to the Grantor (including any person or entity hereafter holding any right, title or interest in or to the Trademark Collateral) to record this Release with the United States Patent and Trademark Office.
