TERMINATION AND RELEASE OF TRADEMARK SECURITY AGREEMENT

This **TERMINATION AND RELEASE OF TRADEMARK SECURITY AGREEMENT** dated as of July 15, 2022 (“Release”), is made by BALANCE POINT CAPITAL PARTNERS III, L.P. as agent (the “Agent”) for itself and the other lending institutions (collectively, the “Lenders”) in favor of TWO-TWENTY RECORDS MANAGEMENT LLC, a Delaware limited liability company (“Two-Twenty”) and INFOSTORE RECORDS MANAGEMENT, LLC, a Delaware limited liability company (“Infostore”, and together with Two-Twenty, each a “Grantor” and collectively, the “Grantors”).

WHEREAS, pursuant to that certain Senior Subordinated Credit Agreement dated as of June 15, 2018 (as amended, restated, supplemented, modified, extended, renewed or replaced from time to time, the “Credit Agreement”) by and among the Grantors, the Agent, and others party thereto, Grantors executed and delivered to the Agent the Trademark Security Agreement, dated as of June 15, 2018 (“Security Agreement”), in which Grantors granted to the Agent a continuing security interest in, and a right to set off against, any and all right, title and interest in and to the Trademarks listed on Schedule A attached hereto (collectively, “Trademark Collateral”).

NOW THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, Agent and Grantors agree as follows:

SECTION 1. Defined Terms. All capitalized terms used herein but not otherwise defined herein have the meanings given to them in the Credit Agreement or Security Agreement.


SECTION 2. Termination and Release. Agent, without representation, warranty, or recourse, hereby:

- (a) terminates, cancels, discharges, and releases the security interest in, and the right to set off against, Grantors’ right, title, and interest in and to all the Trademark Collateral, including, but not limited to, the foregoing listed on Schedule A attached hereto, granted pursuant to the Security Agreement;
- (b) authorizes the recordation of this Release with the USPTO at Grantors’ expense; and
- (c) agrees to provide the Grantors with any information and additional authorization reasonably necessary to effect the release of the Grantors’ security interest in the Trademark Collateral.

SECTION 3. Choice of Law. This Release shall be governed by and construed in accordance with the laws of the State of New York.

IN WITNESS WHEREOF, the Agent has caused this Termination and Release of Trademark Security Agreement to be duly executed as of the date first set forth above.
