**RELEASE OF SECURITY INTEREST IN TRADEMARK COLLATERAL**

This **RELEASE OF SECURITY INTEREST IN TRADEMARK COLLATERAL**, dated as of July 27, 2022 (this "Release"), is made by TCW ASSET MANAGEMENT COMPANY LLC, as the Collateral Agent for itself and certain lenders (in such capacity, together with its successors and assigns, if any, the "Collateral Agent") in favor of Clinactiv Technology Limited, an exempted company incorporated under the laws of the Cayman Islands with limited liability ("Clinactive"), and Obagi Cosmeceuticals LLC, a Delaware limited liability company ("Obagi"), and together with Clinactive, each an "Assignor" and collectively, the "Assignors").

**WITNESSETH**

WHEREAS, the Assignors and Collateral Agent are parties to that certain Pledge and Security Agreement, dated as of March 16, 2021 (as amended, restated, amended and restated, supplemented, modified or otherwise changed from time to time, the "Security Agreement") pursuant to which each Assignor, to secure the payment, performance and observance of the Secured Obligations (as defined in the Security Agreement), assigned to the Collateral Agent and granted to the Collateral Agent for the benefit of the Secured Parties (as defined in the Security Agreement) a continuing security interest in all right, title and interest of such Assignor in, to and under the Collateral (as defined in the Trademark Security Agreement), including without limitation the Trademarks set forth on Schedule I attached hereto, if any;

WHEREAS, pursuant to the Security Agreement, the Assignors executed the Assignment For Security – Trademarks, dated as of March 16, 2021 (the "Trademark Security Agreement") and recorded with the U.S. Patent and Trademark Office on March 31, 2021 at Reel/Frame No. 007297/0904; and

WHEREAS, the Assignors have requested and the Collateral Agent has agreed to terminate and release the entirety of its security interest in the Collateral.

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, and upon the terms set forth in this Release, Collateral Agent hereby **DISCHARGES, TERMINATES, CANCELS and RELEASES** fully, without recourse, representation or warranty of any kind, all of its security interest in the Collateral, including without limitation the Trademarks set forth in Schedule I attached hereto, and agrees that any right, title or interest of the Collateral Agent in the Collateral shall hereby cease and become void. The undersigned hereby re-transfers, re-conveys and re-assigns to the Assignors, without recourse, representation or warranty of any kind, any and all right, title or interest that Collateral Agent may have obtained in, to and under the Collateral under the Security Agreement and the Trademark Security Agreement.

Capitalized terms used in this Release and not otherwise defined herein have the meanings ascribed to such terms in the Security Agreement or the Trademark Security Agreement, as applicable.

The Collateral Agent hereby agrees to duly execute, acknowledge, procure and deliver any further documents and to do such other acts as may be reasonably necessary to effect the release of the security interest contemplated hereby. The Collateral Agent hereby authorizes and requests that the United States Patent and Trademark Office record this Release.
