AFFIDAVIT OF KRISTIN A. GRANT

I, Kristin A. Grant, declare and state as follows:

1. I am an attorney at Grant Attorneys at Law PLLC. The following facts are based upon my personal knowledge, and if called and sworn as a witness, I could and would testify competently thereto. When referencing documents, such documents were prepared by me or at my instruction by other attorneys employed by Grant Attorneys at Law PLLC.
2. I am the attorney of record for Serial No. 88/553549 for the mark PETWORKS ("Petworks mark") and I represent the listed Applicant, Petmasters LLC (currently renamed, Petworks LLC) ("Petmasters").
3. Upon information provided to me by Petmasters, I personally prepared a Trademark Assignment Agreement ("Agreement") between Petmasters and Petworks LLC ("Petworks").
4. This Agreement was then signed by Michael Caldwell, as the CEO of both Petmasters and Petworks.
5. On September 13, 2021, I submitted the executed Agreement and a Trademark Assignment Cover Sheet to the Assignment Recordation Branch ("ARB") of the U.S. Patent & Trademark Office which was recorded on Reel/Frame numbers [REDACTED]
6. After making the submission to the Assignment Recordation Branch, I discovered that there was a misunderstanding between me and Petmasters LLC regarding the nature of the relationship between Petmasters and Petworks. I discovered that Petworks was not a

new and separate entity, but instead, Petmasters' name was merely changed to Petworks with the Connecticut Department of State. See Exhibit A.

7. This deemed the Agreement filed with the ARB null and void.
8. Upon discovering this error, I immediately filed a Corrective Assignment on September 21, 2021 requesting that the nature of the conveyance be corrected from "Assignment of entire interest and goodwill" to "Change of Name".
9. On October 1, 2021, the Corrective Assignment was returned as non-recordable on the basis that the "cover sheet submitted for recording is not acceptable. To record a document in the Assignment Recordation Branch, a document evidencing the assignment must accompany the cover sheet." See Exhibit B. However, with a Change of Name no assignment or assignment document exists.
10. I now submit a response to the Notice of Non-recordation which includes the Certificate of Amendment evidencing the applicant's name change from Petmasters LLC to Petworks LLC and respectfully request correction of the previous submission.

I declare under penalty of perjury under the laws of the United States that the foregoing is true and correct.
