RELEASE OF SECURITY INTEREST  
IN TRADEMARKS

This Release of Security Interest in Trademarks, dated as of June 9, 2022 (this “Release”) is made by PNC BANK, NATIONAL ASSOCIATION, as administrative agent (the “Administrative Agent”), whose address is 500 First Avenue, Pittsburgh, PA 15219, with respect to that certain Grant of Security Interest dated as of September 23, 2016 (the “Security Agreement”) by and among the HO-CHUNK NATION OF WISCONSIN, a Native American sovereign nation which is a federally recognized Indian tribe (the “Debtor”), whose address is W9814 Airport Road, Black River Falls, WI 54615, and the Administrative Agent.

Pursuant to the Security Agreement, the Debtor granted to the Administrative Agent, for the benefit of the secured parties referred to therein, a security interest in and to all of the Debtor’s right, title and interest in the Debtor’s trademarks, service marks, and trade names, trademark and service mark registrations, and applications thereof, including, without limitation, those specific trademark registrations and applications listed on Exhibit A attached hereto (the “Released Trademarks”), and the goodwill associated therewith.

The Security Agreement was recorded on October 27, 2016, at Reel/Frame 5914/0781 in the United States Patent and Trademark Office.


