TRADEMARK ASSIGNMENT

For good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, Assignor hereby irrevocably conveys, transfers and assigns to Assignee all rights, title and interests of Assignor in and to the Trademarks, together with the goodwill of the business connected with the use of, and symbolized by, the Trademarks, as well as Assignor’s entire right, title and interest in and to all federal and state trade and service mark registrations of the Trademarks heretofore granted or applied for, and any and all common law rights to the Trademarks throughout the world, any and all royalties, fees, income, payments, and other proceeds now or hereafter due or payable with respect to the Trademarks, and any and all claims and demands it may have either at law or in equity arising out of any past infringements and uses of the Trademarks.


2. Recordation and Further Actions. Assignor hereby constitutes and appoints Assignee as the true and lawful attorney of Assignor, with full power of substitution, in the name of Assignor or Assignee, but on behalf and for the benefit of Assignee, to execute and take all actions and procedures necessary with the United States Patent and Trademark Office and any other government agency to transfer the Trademarks from Assignor to Assignee.

3. Terms of the Contribution Agreement. The parties hereto acknowledge and agree that this Assignment is entered into pursuant to the Contribution Agreement, to which reference is made for a further statement of the rights and obligations of Assignor and Assignee with respect to the Trademarks. The representations, warranties, covenants, agreements, and indemnities contained in the Contribution Agreement shall not be superseded hereby but shall remain in full force and effect to the full extent provided therein. In the event of any conflict or inconsistency between the terms of the Contribution Agreement and the terms hereof, the terms of the Contribution Agreement shall govern.
