**U.S. TRADEMARK SECURITY AGREEMENT**

U.S. TRADEMARK SECURITY AGREEMENT, dated as of July 29, 2022 (as amended, restated, supplemented or otherwise modified, this “Agreement”), among (i) **TWIN RIVERS PAPER COMPANY LLC**, a Delaware limited liability company (“Twin Rivers U.S.”), and together with any other U.S. Subsidiary that at any time after the date hereof becomes a party to the Credit Agreement referred to below as a Borrower, individually and collectively, the “U.S. Borrower”, (ii) **TWIN RIVERS PAPER COMPANY US HOLDCO LLC**, a Delaware limited liability company (“U.S. Holdco”), (iii) each Subsidiary of U.S. Holdco organized under the laws of the United States party hereto as of the date hereof (collectively with the U.S. Borrower and U.S. Holdco, the “Grantors” and each a “Grantor”) and (iv) **CITIZENS BANK, N.A.**, a national banking association, as Administrative Agent (in such capacity, the “Administrative Agent”).

Reference is made to (a) the Credit Agreement, dated as of July 29, 2022, among (i) the U.S. Borrower, (ii) Twin Rivers Paper Company Inc., a corporation organized under the laws of Ontario, Canada (“Canadian Borrower”, and together with each U.S. Borrower, “Borrowers” and each a “Borrower”), (iii) U.S. Holdco, (iv) the other U.S. Guarantors party thereto, (v) Twin Rivers Holdings Partners, a partnership organized under the laws of New Brunswick, Canada (“Twin Rivers Canada”), (vi) certain Wholly-Owned Subsidiaries of Twin Rivers Canada organized under the laws of Canada (or any province thereof) from time to time parties thereto as Guarantors (together with Twin Rivers Canada, “Canadian Guarantors”), (vii) the Lenders party thereto and (viii) the Administrative Agent (as the same may be amended, restated, supplemented or otherwise modified from time to time, the “Credit Agreement”), and (b) the U.S. Pledge and Security Agreement, dated as of July 29, 2022, by and among the Grantors party thereto and the Administrative Agent (as the same may be amended, restated, supplemented or otherwise modified from time to time, the “Security Agreement”)

The Lenders have agreed to extend credit to the Borrowers subject to the terms and conditions set forth in the Credit Agreement, the U.S. Guarantors have guaranteed Secured Obligations and the Grantors have secured their obligations pursuant to the Security Agreement. The obligations of the Lenders to extend such credit are conditioned upon, among other things, the execution and delivery of this Agreement.

Accordingly, the parties hereto agree as follows:

1. **Terms.** Capitalized terms used in this Agreement and not otherwise defined herein have the meanings specified in the Security Agreement or the Credit Agreement.

2. **Grant of Security Interest.** As security for the payment or performance, as applicable, in full when due (whether at the stated maturity, by acceleration or otherwise) of the Secured Obligations, each Grantor, pursuant to the Security Agreement, did and hereby does grant to the Administrative Agent (and its successors and assigns), for the ratable benefit of the Secured Parties, a security interest in, all such Grantor’s right, title and interest in, to or under any and all of the following assets now owned or at any time hereafter acquired (collectively, the “Trademark Collateral”):

(a) all trademarks, service marks, trade names, corporate names, company names, business names, fictitious business names, trade styles, trade dress, logos, other source or business identifiers, prints and labels on which any of the foregoing have appeared or appear, uniform resource locations (URL’s), domain names, designs and general intangibles of like nature, now existing or hereafter adopted or acquired and all registrations and recordings thereof and all registration and recording applications filed in connection therewith, including registrations and registration applications in the United States Patent and Trademark Office or any similar offices in the United States of America or any other

country, in each case described on Schedule I and all reissues, renewals, continuations and extensions thereof and amendments thereto (the "Trademarks"),

(b) all reissues, continuations, extensions and renewals thereof and amendments thereto,

(c) all goodwill associated therewith or symbolized by any of the foregoing,

(d) all income, fees, royalties, damages and payments now and hereafter due and/or payable thereunder and with respect thereto, and

(e) all other assets, rights and interests that uniquely reflect or embody such goodwill.

3 Security Agreement. The security interests granted to the Administrative Agent herein are granted in furtherance, and not in limitation of, the security interests granted to the Administrative Agent pursuant to the Security Agreement. Each Grantor hereby acknowledges and affirms that the rights and remedies of the Administrative Agent with respect to the Trademark Collateral are more fully set forth in the Security Agreement, the terms and provisions of which are hereby incorporated herein by reference as if fully set forth herein. In the event of any conflict between the terms of this Agreement and the Security Agreement, the terms of the Security Agreement shall govern.



5. Governing Law. This Agreement shall be governed by, and construed in accordance with, the laws of the State of New York.
