**TERMINATION AND RELEASE OF SECURITY INTEREST  
IN TRADEMARKS**

This **TERMINATION AND RELEASE OF SECURITY INTEREST IN TRADEMARKS**, dated as of July 30, 2022 (“Release”), is made by PNC Bank, National Association, as Administrative Agent (“Administrative Agent”) in favor of MaschioPack North America LLC, a Georgia limited liability company (“Pledgor”).

**WHEREAS**, pursuant to that certain Credit Agreement dated as of December 1, 2017 (as amended, restated, modified or supplemented from time to time, the “Credit Agreement”) by and among the Pledgor, Administrative Agent, and others party thereto, and the Patent, Trademark, and Copyright Security Agreement dated as of December 1, 2017 by and among the Pledgor and Administrative Agent (“IP Security Agreement”), Pledgor granted and conveyed a security interest to the Administrative Agent, for itself and the benefit of the Lenders and their respective affiliates, in the entire right, title and interest of Pledgor in and to all Trademarks; and

**WHEREAS**, the IP Security Agreement was recorded at the United States Patent and Trademark Office (“USPTO”) on December 6, 2017 at Reel 6221 Frame 0679.

**NOW THEREFORE**, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, Administrative Agent, on behalf of the Secured Parties, and Pledgor agree as follows:

**SECTION 1. Defined Terms.** All capitalized terms used herein but not otherwise defined herein have the meanings given to them in the Credit Agreement or IP Security Agreement.

**SECTION 2. Termination and Release.** Administrative Agent, on behalf of the Secured Parties, without any representation, warranty, recourse, or undertaking of any kind (whether express or implied), hereby:

(a) terminates, cancels, discharges, and releases the security interest in the entire right, title and interest of Pledgor in and to solely the Trademarks listed on Schedule A attached hereto, granted pursuant to the Credit Agreement or IP Security Agreement; and


(b) authorizes the recordation of this Release with the USPTO at Pledgor’s expense.

**SECTION 3. Choice of Law.** This Release shall be governed by and construed in accordance with the laws of the State of New York.
