RELEASE OF INTELLECTUAL PROPERTY SECURITY AGREEMENT

THIS RELEASE OF INTELLECTUAL PROPERTY SECURITY AGREEMENT dated as of July 29, 2022 (this "Release") is made by WESTERN ALLIANCE BANK, an Arizona corporation (the "Bank"), under that certain Intellectual Property Security Agreement, dated as of July 5, 2019 (the "Initial IP Agreement"), as amended and restated by that certain Amended and Restated Intellectual Property Security Agreement, dated as of April 11, 2022 (the "A&R IP Agreement"), in each case by Stratasan, LLC, a Tennessee limited liability company (the "Grantor") in favor of the Bank (the Initial IP Agreement and the A&R IP Agreement collectively, the "IP Agreements"). Capitalized terms used but not defined in this Release are used in this Release as defined in each of the IP Agreements.

WHEREAS, pursuant to the IP Agreements, the Grantor pledged and granted to the Bank a security interest in all of the Grantor's right, title and interest in and to the Intellectual Property Collateral, including those Trademarks set forth on the attached Exhibit A;

WHEREAS, the obligations secured by the Intellectual Property Collateral have been repaid or otherwise satisfied; and

WHEREAS, the Bank is therefore requested to release, terminate and discharge its security interest in all of the Grantor's right, title and interest in the Intellectual Property Collateral, and the Grantor has requested, and the Bank has agreed to provide, a document suitable for recording in the United States Patent and Trademark Office evidencing and effecting the release, relinquishment and discharge of its security interest in the Intellectual Property Collateral and the termination of the IP Agreements.

NOW, THEREFORE, for good and valuable consideration, the receipt of which is hereby acknowledged, the Bank does hereby, in each case, without recourse, representation or warranty of any kind whatsoever, (a) terminate the IP Agreements and the security interest created under the IP Agreements in the Intellectual Property Collateral (as defined in each of the IP Agreements) (including those Trademarks set forth on the attached Exhibit A), (b) release its security interest in such Intellectual Property Collateral (including those Trademarks set forth on the attached Exhibit A), and (c) discharge any and all rights, title and interest it has in and to the security interest granted to the Bank in such Intellectual Property Collateral (including those Trademarks set forth on the attached Exhibit A).
