**RELEASE OF SECURITY INTEREST AND REASSIGNMENT OF  
PATENTS AND TRADEMARKS**

NOW, THEREFORE, for good and valuable consideration, receipt of which is hereby acknowledged, Agent hereby terminates the Agreement, releases said continuing security interest in, and lien on, the Patents and Trademarks, and retransfers and reassigns to the Company, without representation or warranty, all of Agent's right, title and interest in and to the Patents and Trademarks, including all reissues, continuations or extensions and the goodwill associated therewith.
