INTELLECTUAL PROPERTY ASSIGNMENT

This INTELLECTUAL PROPERTY ASSIGNMENT, effective as of 11:59 p.m. on July 22, 2022 (this “Assignment”), is by and among (i) AHF, LLC, a Delaware limited liability company (the “Assignee”), and (ii) Armstrong Flooring, Inc., a Delaware corporation, and AFI Licensing LLC, a Delaware limited liability company (each an “Assignor”, and collectively, the “Assignors”). Each of the Assignee and the Assignors are referred to herein as a “Party.” Unless otherwise specifically provided herein, each capitalized term used but not defined herein shall have the meaning given to such term in the Asset Purchase Agreement (as defined below).

RECITALS

WHEREAS, the Assignee and the Assignors are parties to that certain Asset Purchase Agreement, dated July 10, 2022 (the “Asset Purchase Agreement”), by and among the Assignee and the Assignors; and

WHEREAS, pursuant to the Asset Purchase Agreement, the Assignors have agreed to sell, assign, transfer, convey and deliver to the Assignee, and the Assignee has agreed to purchase, among other things, certain Intellectual Property.

AGREEMENT

NOW, THEREFORE, in consideration of the premises and the mutual promises and conditions hereinafter set forth and set forth in the Asset Purchase Agreement and the Other Transaction Agreements, and for other good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the Parties, intending to be legally bound, do hereby agree as follows:

1. Conveyance and Acceptance. In accordance with and subject to the provisions of the Asset Purchase Agreement, the Assignors hereby sell, assign, transfer, convey and deliver to the Assignee, and the Assignee hereby purchases and accepts, all of the Assignors’ right, title and interest in and to the Registered IP, including the Assignors’ right, title and interest in and to (i) all the items of Registered IP set forth in Section 3.11(a) of the Company Disclosure Letter to the Asset Purchase Agreement; (ii) all goodwill associated therewith; (iii) all income, royalties, profits, and damages related thereto; (iv) all rights to bring Actions, defend against Actions or recover damages or other compensation for past, present or future infringements, dilutions, misappropriations, or other violations, including the right to sue and obtain equitable relief in respect of such infringements, dilutions, misappropriations or other violations; (v) all rights to apply for, revive and maintain all registrations, renewals and/or extensions of any of the foregoing, (vi) any and all corresponding rights with respect to any of the foregoing that, now or hereafter, may be secured throughout the world; and (vii) the right to fully and entirely stand in the place of the Assignors in all matters related thereto (the “Assigned IP”).

2. Recordal and Perfection. Assignee shall have the right, at Assignee’s cost and expense, to record this Assignment with all applicable governmental authorities and registrars so as to perfect its ownership of the Registered IP. Assignors further hereby agree to execute and deliver to Assignee, its successors and assigns, without further compensation, such other and further assignments, instruments and documents as Assignee reasonably may request from time to

time for the purpose of establishing, registering, evidencing, enforcing or defending Assignee's complete, exclusive, and worldwide (to the extent applicable) ownership of all right, title and interest in and to the Registered IP.

3. Due Authorization. Assignors hereby authorize the appropriate empowered officials at the United States Patent and Trademark Office and all applicable foreign trademark offices, whose duty it is to issue registrations or other evidence or forms of intellectual property protection on applications to register for the Registered IP, as applicable, to issue the same in the name of Assignee and its successors and assigns in accordance with this Assignment.

4. Asset Purchase Agreement Controls. This Assignment is and shall be subject to and governed entirely by and in accordance with the terms and conditions of the Asset Purchase Agreement. Notwithstanding any other provision of this Assignment to the contrary, nothing contained herein shall in any way supersede, modify, replace, amend, change, rescind, waive, exceed, expand, enlarge or in any way affect the provisions of the Asset Purchase Agreement, including any representation, warranty, covenant, agreement, obligation or condition contained therein or the rights or remedies contemplated thereby. To the extent this Assignment conflicts with the Asset Purchase Agreement, the Asset Purchase Agreement will control.

5. Miscellaneous.

(a) Governing Law. Except to the extent of the mandatory provisions of the Bankruptcy Code, this Assignment and all disputes or controversies arising out of or relating to this Assignment or the transactions contemplated hereby (in contract or tort) shall be governed by, and construed in accordance with the internal Laws of the State of Delaware, without regard to the Laws of any other jurisdiction that might be applied because of the conflicts of laws principles of the State of Delaware.

(b) Consent to Jurisdiction; Waiver of Jury Trial. Without limitation of any Party's right to appeal any Order of the Bankruptcy Court, (x) the Bankruptcy Court shall retain exclusive jurisdiction to enforce the terms of this Assignment and to decide any claims or disputes which may arise or result from, or be connected with, this Assignment, any breach or default hereunder, or the transactions contemplated hereby and (y) any and all claims relating to the foregoing shall be filed and maintained only in the Bankruptcy Court, and the Parties hereby consent and submit to the exclusive jurisdiction and venue of the Bankruptcy Court and irrevocably waive the defense of an inconvenient forum to the maintenance of any such Action or proceeding; provided, however, that, if the Chapter 11 Case is closed or declines jurisdiction, each of the Parties irrevocably agrees that any Action or proceeding arising out of or relating to this Assignment brought by another Party or its successors or assigns shall be heard and determined in the Court of Chancery of the State of Delaware, or if jurisdiction is not available in the Court of Chancery, then in the United States District Court for the District of Delaware, and each of the Parties hereby irrevocably submits to the exclusive jurisdiction of the aforesaid courts for itself and with respect to its property, generally and unconditionally, with regard to any such action or proceeding arising out of or relating to this Assignment and the transactions contemplated hereby. Each of the Parties further agrees that notice as provided herein shall constitute sufficient service of process and the Parties further waive any argument that such service is insufficient, without limiting any other manner of service permitted by Law. Each of the Parties hereby irrevocably

and unconditionally waives, and agrees not to assert, by way of motion or as a defense, counterclaim or otherwise, in any action or proceeding arising out of or relating to this Assignment or the transactions contemplated hereby, (a) any claim that it is not personally subject to the jurisdiction of the courts of the State of Delaware, and of the United States District Court for the District of Delaware as described herein for any reason, (b) that it or its property is exempt or immune from jurisdiction of any such court or from any legal process commenced in such courts (whether through service of notice, attachment prior to judgment, attachment in aid of execution of judgment, execution of judgment or otherwise) and (c) that (i) the suit, action or proceeding in any such court is brought in an inconvenient forum, (ii) the venue of such suit, action or proceeding is improper or (iii) this Assignment, or the subject matter hereof, may not be enforced in or by such courts. **EACH OF THE PARTIES HEREBY IRREVOCABLY WAIVES ANY AND ALL RIGHT TO TRIAL BY JURY IN ANY LEGAL PROCEEDING ARISING OUT OF OR RELATED TO THIS ASSIGNMENT OR THE TRANSACTIONS CONTEMPLATED HEREBY.**




